## Ordinance First Reading

### ORDINANCE 13-12

# AN ORDINANCE TO AMEND SECTION 14-33 (a) OF THE GILLETTE CITY CODE CONCERNING CONCEALED WEAPONS OTHER THAN FIREARMS

It was moved by Councilwoman Carter-King and seconded by Councilman Jerred to approve the foregoing ordinance on first reading. Mayor Murphy asked for background information concerning the ordinance. City Attorney Anderson explained the ordinance is intended to clarify the regulations for concealed weapons and concealed firearms. It clarifies that an individual who has a concealed firearm permit from the State, or one who could qualify to receive a permit, could possess a concealed firearm in the city of Gillette. It also clarifies that because you have a concealed firearm permit, does not mean you can carry other concealed weapons in the city of Gillette. Mayor Murphy asked the reason for the change. Mr. Anderson explained that this ordinance has caused some confusion in the Municipal Court; to dispel that confusion, there were very small changes made to the ordinance that is before Council this evening. After the discussion, roll was called on the motion with the following results. Council Members voting aye: McGrath, Opseth, Rothleutner, Carter-King, Kuntz, Jerred, and Mayor Murphy. The Presiding Officer declared the motion carried.

#### ORDINANCE 13-13

AN ORDINANCE TO AMEND PORTIONS OF SECTION 11-10(C) (3) OF THE GILLETTE CITY CODE TO EXTEND THE SNOW ROUTE ON 6TH STREET TO GILLETTE AVENUE AND TO ENACT SECTION 11-12 (h) OF THE GILLETTE CITY CODE CONCERNING PARKING ON DRIVEWAYS AND SIDEWALKS

It was moved by Councilman Rothleutner and seconded by Councilman Opseth to approve the foregoing Ordinance on first reading. Mayor Murphy asked for background information concerning the ordinance. City Administrator Napier explained this amendment has two parts; the first part deals with parking and driveways that have caused concern for some neighbors with longer vehicles that encroach on sidewalks for those properties that have the smaller driveways. After evaluating this issue, it does seem appropriate to allow vehicles to extend beyond the limits of their driveway into the sidewalk. However, this ordinance does not allow for the encroachment of trailers with tongues that extend over the sidewalk, or other pieces of equipment. The second part of the amendment is in regard to connecting the gap on an emergency route between the downtown and the hospital district. The current emergency route extends from 4-J Road to Burma Road along 6th Avenue; but not from 4-J Road to Gillette Avenue and this amendment would connect that gap. Mayor Murphy commented that there is more traffic on 6th Street since the traffic light was installed, and thus would require this to be a snow emergency route. Councilman McGrath requested that staff notify the residents in this area of this change. Councilman Jerred requested the residents also be notified that they cannot block the sidewalk. After the discussion, roll was called on the motion with the following results. Council Members voting aye: Opseth, Rothleutner, Carter-King, Kuntz, Jerred, McGrath, and Mayor Murphy. The Presiding Officer declared the motion carried.

#### New Business

### **RESOLUTION 2413**

# A RESOLUTION DETERMINING THAT THE CONSTRUCTION OF THE TRANSMISSION LINE PROJECT HAS BEEN COMPLETED AND ACCEPTED BY THE CITY OF GILLETTE AND ALL COSTS OF ACQUISITION AND CONSTRUCTION HAVE BEEN PAID.

It was moved by Councilwoman Carter-King and seconded by Councilman Rothleutner to approve the foregoing Resolution determining that the construction of the Transmission Line Project has been completed and accepted by the City of Gillette and all costs of acquisition and construction have been paid. Mayor Murphy asked for background information. City Administrator Napier explained this is the transmission line that was constructed as part of the WYGEN purchase and will allow for the trustees to reimburse the City for the remaining balance in the project fund of \$403,959.24. After the discussion, roll was called on the motion with the following results. Council Members voting aye: Rothleutner, Carter-King, Kuntz, Jerred, McGrath, Opseth, and Mayor Murphy. The Presiding Officer declared the motion carried.

It was moved by Councilman Opseth and seconded by Councilwoman Carter-King to approve the CT II Purchase and Sale Agreement between Black Hills Wyoming, LLC, and Consolidated Wyoming Municipalities Electric Power System Joint Powers Board. Mayor Murphy asked for background information. City Administrator Napier the potential authorization represents explained that a culmination of work in regards to the evaluation of the potential purchase of the CT II Combustible Turbine power plant. Mr. Napier commented that he believes this process has been fruitful and Black Hills has been excellent to work with. He went on to say that the purchase the City is about to enter into is appropriate and will mean a benefit in regards to our rate payers, and our power fund, that will assist in avoiding costs that we would have otherwise incurred. Utilities Director Glover explained that the turbine is located at Wyodak and is a gas fired unit that has been in service for approximately 10-11 years. He went on to say when Black Hills introduced the economics of this unit, it basically hedges the market and enables for the purchase of inexpensive power in order to provide the citizens with the cheapest possible power. The unit runs when it is most effective and efficient to run; when there is cheaper power to purchase, it will sit idle. Mr. Glover went on to explain the unit and the agreement. Councilwoman Carter-King asked about the benefit of savings to the citizens being \$35,000,000 to \$100,000. Mr. Glover stated that the consultant indicated with the variables in the cost of natural

gas, variables in the cost of coal mining, and variables in operational costs to produce electricity, the consultant stated the City could expect a \$35,000,000 to \$100,000,000 savings over 20 years as compared to continuing to purchase power, like it's done at this time. Councilman McGrath asked about the maintenance issue and the warranty concerning the unit. Mr. Glover said there was an oil leak that was discovered and Black Hills has sent the unit to Canada to replace any seals to ensure that there will be no future problems relating to this issue of the oil leak. Councilman McGrath then asked for confirmation that Mark Lux, during a Work Session meeting, stated that Black Hills would not sell this unit if there were leaks or any other problems with the turbine. Mr. Lux affirmed that Black Hills will do everything in their power to ensure the leak is repaired before they would accept the performance of the turbine in terms of the maintenance repairs that were done. Mr. Lunx went on to say that Black Hills would not accept it for their purposes, and would not accept it for the purpose of selling the engine to the City of Gillette. Councilman McGrath asked Mr. Glover what the warranty period is. Mr. Glover stated that the typical warranty period on a combustible turbine is one year. In regard to this problem that was identified, negotiations were done with Black Hills for a two year period or the equivalent hours, and a \$2,000,000 warranty. City Administrator Napier added the two year warranty will begin post closing when the City takes ownership. Councilman Kuntz stated that it is important to notify the public that this does not mean there will not be rate increases in the future; but if rates due increase, they will be significantly less. After further discussion, roll was called on the motion with the following results. Council Members voting aye: Carter-King, Kuntz, Jerred, McGrath, Opseth, Rothleutner, and Mayor Murphy. The Presiding Officer declared the motion carried.

### **RESOLUTION 2414**

WHEREAS, the Campbell County Lodging Tax Joint Powers Board wishes to expand and diversify Wyoming's economy by incrementally growing Wyoming's tourism industry; and

WHEREAS, the existing Visitor's Center in Gillette has been leased from the City of Gillette since 1995; and

WHEREAS, the City of Gillette is one of entities who formed the Campbell County Lodging Tax Joint Powers Board; and

WHEREAS, the Campbell County Lodging Tax Joint Powers Board intends to submit an application for a Business Ready Community Planning Grant from the Wyoming Business Council to perform a Gillette Visitor Center Study. Based on highway traffic counts and the Visitor Center traffic counts, the study will evaluate possible locations and costs, building size and design/floor plan and costs, and any potential community partners to be officed in the building; and

WHEREAS, the City of Gillette supports the grant application and will match Campbell County and supply \$6,000 towards the local match; and

NOW, THEREFORE, BE IT RESOLVED by the City of Gillette, to approve an application from the Campbell County Lodging Tax Joint Powers Board for \$25,000 for the Business Ready Community Grant and Loan Program for a Planning Grant to perform a Gillette Visitor Center Study. Based on highway traffic counts and the Visitor Center traffic counts, the study will evaluate possible locations and costs, building size and design/floor plan and costs, and any potential community partners to be officed in the building. The Mayor and the City Administrator are authorized to execute project related documents on behalf of Gillette.

It was moved by Councilman Rothleutner and seconded by Councilman Jerred to approve the foregoing Resolution to authorize a Business Ready Community Grant and Loan Program Planning Grant Application by the Campbell County Lodging Tax Joint Powers Board to the Wyoming Business Council. Mayor Murphy asked for background information. City Administrator Napier explained that the Lodging Tax Joint Powers Board wants to have a study done with regards to a potential location for a new Visitor's Center. The Business Council has funds available for this study to occur and pursuant to the granting program, the partner entities need to offer their authorization for the grant to move forward. After the discussion, roll was called on the motion with the following results. Council Members voting aye: Kuntz, Jerred, McGrath, Opseth, Rothleutner, Carter-King, and Mayor Murphy. The Presiding Officer declared the motion carried.

It was moved by Councilman Kuntz and seconded by Councilman McGrath to approve a Memorandum of Understanding between the City of Gillette and Campbell County Parks and Recreation Department for City of Gillette swimming pool operations. Mayor Murphy asked for discussion. Councilman Rothleutner asked if this is the standard for an agreement of staffing for the City Pool. City Administrator Napier affirmed it was and went on to say that we are only charged for what the direct costs are and the number will not exceed \$75,000. After the discussion, roll was called on the motion with the following results. Council Members voting aye: Jerred, McGrath, Opseth, Rothleutner, Carter-King, Kuntz and Mayor Murphy. The Presiding Officer declared the motion carried.

It was moved by Councilman Opseth and seconded by Councilman Jerred to accept public improvements for the Boxelder Road Extension Phase II-A Project installed by S&S Builders, LLC, in the amount of \$1,528,217.96. Mayor Murphy commented that this is a One Percent Project and then asked for discussion. There was none. Roll was called on the motion with the following results. Council Members voting aye: McGrath, Opseth, Rothleutner, Carter-King, Kuntz, Jerred, and Mayor Murphy. The Presiding Officer declared the motion carried.

It was moved by Councilwoman Carter-King and seconded by Councilman Jerred to accept development improvements for the Maverick Store Water and Sanitary Sewer Main Extension Project, installed by DRM, Inc., on behalf of the developer, Maverick, Inc. Mayor Murphy asked for discussion. There was none. Roll was called on the motion with the following results. Council Members voting aye: Opseth, Rothleutner, Carter-King, Kuntz, Jerred, McGrath, and Mayor Murphy. The Presiding Officer declared the motion carried.

It was moved by Councilman Jerred and seconded by Councilman Kuntz to approve a catering permit requested by Jordan's Fine Western Dining for May 18<sup>th</sup> from 6:30 p.m. to midnight in celebration of their grand opening that will include outdoor music. Mayor Murphy asked for discussion. There was none. Roll was called on the motion with the following results. Council Members voting aye: Rothleutner, Carter-King, Kuntz, Jerred, McGrath, Opseth, and Mayor Murphy. The Presiding Officer declared the motion carried.

# Administrator's Report

Mayor Murphy asked for an Administrator's Report. City Administrator Napier said there was none.
