For the Good of the Community

The Mayor and Council recognized Jeremy Harder for the 2013 "Hometown Media Award" in the Entertainment and Arts Access Center Professional Category.

Public Information Officer Lunne gave a presentation of past and upcoming events around the community. During the presentation, notification was given concerning the Gurley Overpass closure for a routine inspection on June 6th & 7th, between the hours of 9:00 a.m. and 3:00 p.m. After the presentation, Councilman McGrath directed staff to contact Burlington Northern to ask for their cooperation and not block the railroad crossings at Brooks Avenue and Burma Avenue during the times of the closure.

Public Comments

Dave Allison addressed the Council by asking for their cooperation with the County and budget money for the Air Enhancement Services. Mayor Murphy informed Mr. Allison the County's request was

received too late for consideration in this year's budgeting process; however, a Task Force is being created, which will include three Council Members, to determine the possible need for discussion during next year's budgeting process. Mr. Allison then touched on revenues that have been reported to be on the decline for the City and the County, and asked the Council to be cognizant of their budgeting decisions concerning the Field of Dreams.

Roll was called on the motion with the following results. Council Members voting aye: McGrath, Carter-King, Kuntz, Jerred, and Mayor Murphy. Voting nay: Rothleutner. The Presiding Officer declared the motion carried.

Roll was called on the motion with the following results. Council Members voting aye: Rothleutner, Carter-King, Kuntz, Jerred, McGrath, and Mayor Murphy. The Presiding Officer declared the motion carried.

Ordinance Second Reading

ORDINANCE 13-14

AN ORDINANCE TO AMEND SECTION 16-3 OF THE GILLETTE CITY CODE CONCERNING ENFORCEMENT OF SECTION 17-21 GCC BY SPECIAL MUNICIPAL OFFICERS

It was moved by Councilwoman Carter-King and seconded by Councilman Jerred to approve the foregoing Ordinance on second reading. Mayor Murphy asked for discussion. Councilman McGrath once again stated that he cannot support an Ordinance that authorizes anyone other than a law enforcement officer to issue citations. Councilman Jerred stated that after careful consideration, he will be voting to nay. Councilwoman Carter-King asked if the Special Municipal Officers receive training. City Administrator Napier stated that Municipal Officers do receive training in writing citations, dealing with troubled customers, etc. Councilwoman Carter-King asked if there have been any

instances, with the current Municipal Officer, threatening their safety. City Attorney Anderson stated there are Animal Control Officers who issue citations for animal violations and supposes that there probably have been some circumstances where a police officer was called for assistance. There have been police officers called for assistance with building code violations, and stated that there is excellent cooperation between the Special Municipal Officers and the Police Officers. Councilwoman Carter-King asked if the Ordinance is voted down, would it revert to only Police Officers issuing the citations. City Administrator Napier affirmed that as far as issuing the citations that is correct; however, that doesn't mean that staff could not build a case in regard to the complaints. Councilman Jerred stated there would be a few warnings given prior to the citation being issued, and asked if staff would have radio dispatch capabilities. City Administrator Napier replied that staff would make several attempts to contact the property owner. It is his understanding they don't carry hand held radios, but carry cell phones. Mayor Murphy asked if the vehicles they use have two-way radios. Mr. Napier replied that it is common for City vehicles to have two-way radios. Councilwoman Carter-King asked staff to keep Council updated concerning citations that are issued for violations of water wasting. After the discussion, roll was called on the motion with the following results. Council Members voting aye: Carter-King and Mayor Murphy. Council Members voting nay: Kuntz, Jerred, McGrath, Rothleutner. The Presiding Officer declared the motion defeated and the Ordinance does not pass on second reading.

<u>Appointments</u>

It was moved by Councilman McGrath and seconded by Councilwoman Carter-King to appoint Mayor Murphy as voting delegate and City Administrator Napier as the alternate voting delegate, for the 2013 WAM Convention Business Meeting to be held in Riverton, Wyoming, on Saturday, June 15, 2013. Mayor Murphy asked City Administrator Napier if the Wyoming Association of Municipalities was contacted to inquire if they would allow him to be the alternate voting delegate. Mr. Napier affirmed that was correct. Roll was called on the motion with the following results. Council Members voting aye: Kuntz, Jerred, McGrath, Rothleutner, and Carter-King. Mayor Murphy abstained. The Presiding Officer declared the motion carried.

Administrator's Report

Mayor Murphy asked for an Administrator's Report. City Administrator Napier said there was none.

Special Orders of the Day

Mayor Murphy opened into a public hearing for the transfer of ownership of a retail liquor license from Pat's Liquors, Inc., to BGM Partners, LLC, d.b.a. Pat's Drive-Up Liquor, located at 600 S. Douglas Hwy. Bruce Brown, representative of BGM Partners, LLC, was available for questions. Councilman Jerred asked if the business would remain as Pat's Liquor. Mr. Brown affirmed that was correct and informed Council the intent was to create an Irish Pub Theme. No further comments were made and Mayor Murphy closed the public hearing.

It was moved by Councilman Jerred and seconded by Councilman Rothleutner to approve the transfer of ownership of a retail liquor license from Pat's Liquors, Inc., to BGM Partners, LLC, d.b.a. Pat's Drive-Up Liquor, located at 600 S. Douglas Hwy. Mayor Murphy asked for discussion. There was none. Roll was called on the motion with the following results. Council Members

voting aye: Jerred, McGrath, Rothleutner, Carter-King, Kuntz, and Mayor Murphy. The Presiding Officer declared the motion carried.

Mayor Murphy opened into a public hearing concerning a Zoning Map Amendment for Tracts 1-3 of the Proposed Cedar Rim Estates Subdivision, with Tract 1 to be Zoned C-1, General Commercial District, Tract 2 to be Zoned R-3, Single and Multiple Family Residential District, Tract 3 to be Zoned A, Agricultural Zoning District, and the Beaver Drive Right-of-Way to be Zoned to the Centerline and Correspond with the Adjacent Zoning Districts, as Shown on the Attached Exhibit 'A' and Exhibit 'B' Maps, Subject to all Planning Requirements. No comments were made and Mayor Murphy closed the public hearing.

ORDINANCE 13-17

AN ORDINANCE TO AMEND THE DISTRICT ZONING MAP OF THE CITY OF GILLETTE, WYOMING, FOR PROPERTY GENERALLY LOCATED AT 1881 SOUTH BURMA AVENUE AND LEGALLY DESCRIBED AS TRACTS 1-3 OF THE PROPOSED CEDAR RIM ESTATES SUBDIVISION, WITH TRACT 1 TO BE ZONED C-1, GENERAL COMMERCIAL DISTRICT, TRACT 2 TO BE ZONED R-3, SINGLE AND MULTIPLE FAMILY RESIDENTIAL DISTRICT, TRACT 3 TO BE ZONED A, AGRICULTURAL ZONING DISTRICT, AND THE BEAVER DRIVE RIGHT-OF-WAY TO BE ZONED TO THE CENTERLINE AND CORRESPOND WITH THE ADJACENT ZONING DISTRICTS, AS SHOWN ON THE ATTACHED EXHIBIT 'A' AND EXHIBIT 'B' MAPS, SUBJECT TO ALL PLANNING REQUIREMENTS

It was moved by Councilwoman Carter-King and seconded by Councilman Kuntz to approve the foregoing Ordinance on first reading. Mayor Murphy asked for discussion. There was none. Roll was called on the motion with the following results. Council Members voting aye: McGrath, Rothleutner, Carter-King, Kuntz, Jerred, and Mayor Murphy. The Presiding Officer declared the motion carried.

Mayor Murphy opened into a public hearing concerning a Zoning Map amendment for Lot 1, Lakeland Hills Commercial Subdivision from C-P, Planned Neighborhood Business Zoning District to C-1, General Commercial Zoning District, Subject to all Planning Requirements. Councilwoman Carter-King asked for the Planning Commission's outcome when they considered the request. Senior Planner Surface explained that the vote was unanimous to move forward for City Council's consideration. Councilman Jerred asked what type of business is going in the C-1 Zoning District. Mr. Surface stated that Kum & Go is the applicant and they want to put in a convenience store and gas station. Councilwoman Carter-King asked for an explanation of a C-P zoning. Mr. Surface explained that a C-P Zoning is for neighborhood businesses and C-1 is for a great range of businesses. There was discussion concerning access to the property and Mr. Surface stated that the rezoning request is one step in the process and there are further details that need to be addressed, including the access; for the safety of the drivers as well as for the success of Kum & Go. After further discussion, Mayor Murphy closed the public hearing.
