A RESOLUTION TO RENAME
BOXELDER ROAD BETWEEN LAKEWAY ROAD AND
THE 4-J ROAD
HARDER DRIVE

BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF
GILLETTE, WYOMING:

SECTION ONE. The City declares that Boxelder Road, sometimes referred to as West Boxelder Road, between Lakeway Road and the 4-J Road shall be known henceforward as Harder Drive.

SECTION TWO. The City finds that Boxelder Road changes to Harder Drive, South of the intersection with Lakeway Road currently and is a source of obvious confusion to the public. New construction will cause the portion of Boxelder Road renamed Harder Drive to terminate in a T intersection with the remainder of Boxelder Road. A new road segment has been constructed to extend Boxelder Road to the West to intersect with Skyline Drive.

SECTION THREE. The portion of Boxelder Road renamed Harder Drive is located in:

T 50 N, R. 72 West of the 6th P.M.

Section 33 : NE 1/4

Section 28 : SE 1/4
