**NOTICE OF PUBLIC HEARING ON JULY 1, 2013 DURING
THE REGULAR MEETING OF THE GILLETTE CITY
COUNCIL, TO CONSIDER A RESOLUTION TO RENAME
BOXELDER ROAD, BETWEEN LAKEWAY ROAD AND THE
4-J ROAD, HARDER DRIVE**

The City of Gillette will hold a public hearing on July 1, 2013 during the Regular Meeting of the Gillette City Council to receive public comment on A Resolution to Rename Boxelder Road, Between Lakeway Road and the 4-J Road, Harder Drive. If approved, new street signs will be erected along the portion of the existing Boxelder Road between Lakeway Road and the intersection with the new part of Boxelder Road, and new addresses issued to the tracts of land on that part of Boxelder that will be changed to Harder Drive. The Resolution is scheduled for consideration by the Gillette City Council after the conclusion of the Public Hearing. A copy of the proposed Resolution is available from the City Clerk at City Hall during normal business hours. The July 1, 2013 Regular Meeting of the Gillette City Council begins at 7:00 P.M.

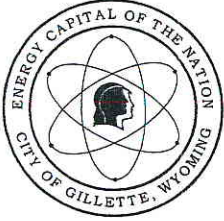

Dear Resident,

This letter is to inform you that due to upcoming changes in the realignment of West Boxelder Road the City Council is considering a road name change from West Boxelder Road to Harder Drive for the portion of West Boxelder Road that extends from just south of the Campbell County Sheriff's Office to West Lakeway Road. The new construction will extend West Boxelder Road from 4-J Road to Burma Avenue. This change will render West Boxelder Road addresses from south of the Campbell County Sheriff's Office to West Lakeway Road invalid and in need of change. The following addresses will be affected in this fashion:

- 2200 West Boxelder Road will be **2200 Harder Drive** (This is City property.)
- 2300 West Boxelder Road will be **2300 Harder Drive** (Owned by Elder Care Inc)
- 2500 West Boxelder Road will be **2500 Harder Drive** (This is City property.)
- 2600 West Boxelder Road will be **2600 Harder Drive** (This is City property.)
- 2701 West Boxelder Road will be **2701 Harder Drive** (Owned by Stanley & Jennifer Dorn.)

On Monday, July 1st the City Council will be holding a public hearing regarding this proposed change, the public is encouraged to attend and participate. If the proposed change comes to fruition, the Postmaster at the U.S. Postal Service will be informed of the road name change, but it will be the responsibility of the resident to coordinate and ensure that the post office is aware of your new address.
