PAVEMENT MARKING PROJECT 13EN30

As generally described, this project is related to the Citywide application of roadway and pavement markings to include, but not limited to, the following components: Striping double yellow centerlines, solid white shoulder lines, dashed white lane lines, dashed yellow turn lane lines, solid white staging area lines, directional arrows, stop bars and crosswalks. Also included are parking lots, on-street parking stalls, and handicap symbols. Miscellaneous curb cleaning and painting as requested by Owner.

This work will conform to the latest edition of the City of Gillette Standard Construction Specifications (hereinafter referred to as SCS).

By submission of this QUOTE, each CONTRACTOR certifies, and in the case of a joint QUOTE each party thereto certifies as to his own organization, that this QUOTE has been arrived at independently, without consultation, communication, or agreement as to any matter relating to this QUOTE with any other CONTRACTOR or with any competitor.

CONTRACTOR hereby agrees to commence WORK immediately upon award of the quote. Completion dates are set forth in section SP-10 of the special provisions. The contract will be extended by the number of weather days approved by the OWNER. **CONTRACTOR shall be available to do touch up work as requested by the OWNER within one week of notification.**

CONTRACTOR further agrees to pay, as liquidated damages, the sum of \$100.00 for each consecutive calendar day that expires after the specified completion date until the work is completed.

CONTRACTOR agrees to perform all the work described in the QUOTE for the following sum:

\$ 109,020.30 The quantities are estimated and may increase or decrease. In case of changes

in quantities, unit price shall govern. **This price quote is for the first application of striping to**

be done in Sep/Oct 2013. Final payment will be based on actual quantities of Bid Items

applied (see SP-10). All prices shall stay in effect through the striping season of 2013/2014. The

Quote Agreement shall be referenced for contract renewability language.




CONTRACTOR shall submit with this Quote Form the following attachments:
