Gary and Shirley Pettigrew informed Council that they have submitted a bill to the City requesting payment for two (2) pumps that, according to them, had been damaged as a result of the City testing their wells in preparation of shutting down the Madison pipeline. Ms. Pettigrew went on to explain their position, gave background information for the basis of their claim, and then respectfully asked the Council to reimburse them for their pumps.

City Administrator Napier explained that this is an agreement that allows for the usage of effluent that is discharged from the Wastewater Treatment Facility. This particular agreement reduces the amount of effluent that the power plant would use, but more closely reflects what they have taken from the Wastewater Treatment Facility. After the discussion, roll was called on the motion with the following results. Council Members voting aye: Jerred, McGrath, Opseth, Rothleutner, Kuntz, and Mayor Murphy. The Presiding Officer declared the motion carried.
