It was moved by Councilman McGrath and seconded by Councilman Rothleutner to approve the foregoing Resolution supporting Governor Mead's Unified Network Phase I and II proposal. Council President Opseth asked for an explanation of the request. Acting City Administrator Glover explained that Governor Mead supports the advancement of technology and broadband continuity for the entire state of Wyoming, and this Resolution shows the support from the City of Gillette. After the explanation, roll was called on the motion with the following results. Council Members voting aye: McGrath, Rothleutner, Carter-King, Kuntz, Jerred, and Council President Opseth. The Presiding Officer declared the motion carried.

It was moved by Councilman Rothleutner and seconded by Councilman McGrath to approve a revised easement to the Campbell County District for a water tank site. Council President Opseth asked for an explanation of the request. Acting City Administrator Glover explained this is an extension of a previous agreement that Council had approved on December 3, 2012. The intention of the Cemetery Board is to install an additional water tank which will improve the effectiveness of their irrigation. The bids for the project were received, and were higher than anticipated; therefore, the Cemetery District is requesting additional time to construct the water tank. After the explanation, roll was called on the motion with the following results. Council Members voting age: Rothleutner, Carter-King, Kuntz, Jerred, McGrath, and Council President Opseth. The Presiding Officer declared the motion carried.

It was moved by Councilwoman Carter-King and seconded by Councilman McGrath to approve a quitclaim deed to the Campbell County Cemetery District to resolve discrepancies in the boundary of the Mount Pisgah Cemetery. Council President Opseth asked for discussion. There was none. Roll was called on the motion with the following results. It was moved by Councilwoman Carter-King and seconded by Councilman Jerred to accept subdivision improvements for the Westover Hills Subdivision, Phase IV, installed by Mountain Peak Builders, LLC, on behalf of the developers, Gary and Trana Johnson. Council President Opseth asked for an explanation of the request. Acting City Administrator Glover explained that the request involves 158 linear feet of 8" PVC water main, 945 square yards of 6" concrete paving, and 326 linear feet of concrete curb and gutter. After the explanation, roll was called on the motion with the following results. Council Members voting aye: Kuntz, Jerred, McGrath, Rothleutner, Carter-King, and Council President Opseth. The Presiding Officer declared the motion carried.

It was moved by Councilman Jerred and seconded by Councilman Rothleutner to approve a bid award for the material procurement of storm sewer box culvert associated with the Gillette Avenue Improvement Project to Cretex Concrete Products in the amount of \$239,356. Council President Opseth asked for discussion. Councilman Jerred asked if the bid award is being considered at this time so there will be no waiting on these materials when the Gillette Avenue project begins. Acting City Administrator Glover confirmed that was correct. Councilman Jerred asked if the staging area had been determined. Development Services Hamilton stated they were

currently working with the Fire Department to possibly use the north end of Fire Station 1 since this is in close proximity to the site. After the discussion, roll was called on the motion with the following results. Council Members voting aye: Jerred, McGrath, Rothleutner, Carter-King, Kuntz, and Council President Opseth. Acting City Administrator Glover explained that this is a broadband study within the city limits and the county, to ensure that we can facilitate all commercial growth needs; it will allow for the hiring of a consultant to determine what the local business needs are, what the interests from the local residential market may be, and to have a master plan that will sync well with the State's efforts to provide faster speeds and larger broadband opportunities. Mark Hines, DOWL HKM, reported that his company is in support of the grant application. No further comments were made and Council President Opseth closed the public hearing.

WHEREAS, the City of Gillette wishes to ready the community for new business development through economic or educational development projects which may include telecommunications services, such as the availability of significant fiber optic bandwidth infrastructure to serve the needs of modern business; and,

WHEREAS, the City of Gillette Broadband Study will provide recommendations to the Gillette City Council to most efficiently encourage and promote fiber optic bandwidth development to support local business technology; and,

WHEREAS, the City of Gillette intends to submit an application to the Wyoming Business Council for a Business Ready Community Planning Grant for the Gillette Broadband Study;
