A RESOLUTION AUTHORIZING SUBMISSION OF AN APPLICATION TO THE BUSINESS READY COMMUNITY GRANT AND LOAN PROGRAM FOR A COMMUNITY ENHANCEMENT GRANT PROJECT ON BEHALF OF THE GOVERNING BODY FOR THE CITY OF GILLETTE FOR THE DOWNTOWN CONVERTIBLE STREET-PUBLIC PLAZA PROJECT IN THE AMOUNT OF \$500,000.

WHEREAS, the Governing Body for the City of Gillette desires to participate in the Business Ready Community Grant And Loan Program to assist in financing this project; and

WHEREAS, the Governing Body of the City of Gillette recognizes this project will develop, and enhance infrastructure within the boundaries of Gillette Wyoming; and

WHEREAS, the Business Ready Community Grant And Loan Program requires that certain criteria be met, as described in the Wyoming Business Council's Rules governing the program, and to the best of our knowledge this application meets those criteria; and

WHEREAS, the Governing Body of the City of Gillette plans to fund the 50% local match for the requested Business Ready Community Enhancement Grant And Loan Program Project from its own resources; and,

WHEREAS, the City of Gillette held a public hearing on February 18, 2013 at 7:00 p.m. in the Council Chambers at City Hall, 201 E. 5th Street, Gillette, Wyoming seeking citizen input regarding this project.; and

WHEREAS, the City of Gillette engaged the private sector with the market area and gave full consideration to all comments received; and

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF GILLETTE, that a grant application in the amount of \$500,000 be submitted to the Wyoming Business Council for consideration of assistance in funding the Downtown Convertible Street-Public Plaza Project.

BE IT FURTHER RESOLVED, that Mayor John Opseth, as the chief elected official will be the authorized representative of the City of Gillette to act on matters relating to this grant application.
