Sam Clikeman, owner of Big Lost Meadery, LLC, explained in order to produce alcohol, or in this case wine, a Federal Basic Permit is needed. After the discussion, roll was called on the motion with the following results. Council Members voting aye: Kuntz, McGrath, Rothleutner, Carsrud, Jerred, and Council President Carter-King. The Presiding Officer declared the motion carried.
