Councilman McGrath stated he supports the budget with the exception of funds for a roof to cover the sand spreaders requested by the Streets Department. Councilman Rothleutner stated he supports the budget, however, he will be abstaining from all budget matters pertaining to personnel. Councilman Kuntz stated he supports the budget with the exception of the request of one full time employee and three seasonal employees for the Field of Dreams. After the discussion, roll was called on the motion with the following results. Council Members voting aye: Carter-King, Jerred, Kuntz, McGrath, Carsrud, and Mayor Opseth. Councilman Rothleutner voted aye, however, abstained from budget matters pertaining to personnel. The Presiding Officer declared the motion carried.
