AN ORDINANCE TO AMEND THE DISTRICT ZONING MAP OF THE CITY OF GILLETTE, WYOMING, FOR UNPLATTED PROPERTY GENERALLY LOCATED WEST OF CHARA AVENUE, SOUTH OF SHALOM AVENUE AND NORTH OF BOXELDER ROAD FROM A, AGRICULTURAL DISTRICT, TO R-S, SUBURBAN RESIDENTIAL DISTRICT, SUBJECT TO ALL PLANNING REQUIREMENTS

MORE PARTICULARLY DESCRIBED AS:
