

ORDINANCE NO.

AN ORDINANCE PROVIDING FOR THE VACATION
OF JORDAN COURT WITHIN CASTLE HEIGHTS ESTATES SUBDIVISION,
BLOCK 2, PHASE I, AS SHOWN ON THE EXHIBIT "A" MAP, IN THE CITY OF
GILLETTE, WYOMING, SUBJECT TO ALL PLANNING REQUIREMENTS

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GILLETTE,
WYOMING:

Section 1.

Pursuant to the petition of the owners of Castle Heights Estates Subdivision, Block 2, Phase I, and the authority of §15-6-104 and §34-12-106 through 110 W. S., City Council finds that the Vacation of Jordan Court as Shown on the Exhibit "A" Map, will not abridge or destroy any of the rights and privileges of other proprietors in the said Castle Heights Estates Subdivision, Phase I and further finds that the Vacation is in the best interest of the City of Gillette. For a more particular legal description see the attached Exhibit "A" Map.

Section 2.

- (a) The right-of-way of Jordan Court in Castle Heights Estates Subdivision, Block 2, Phase I, as Shown on the Exhibit "A" Map, is hereby vacated.
- (b) The ordinance and Exhibit "A" Map shall; be recorded at the County Clerk's Office upon approval by City Council.

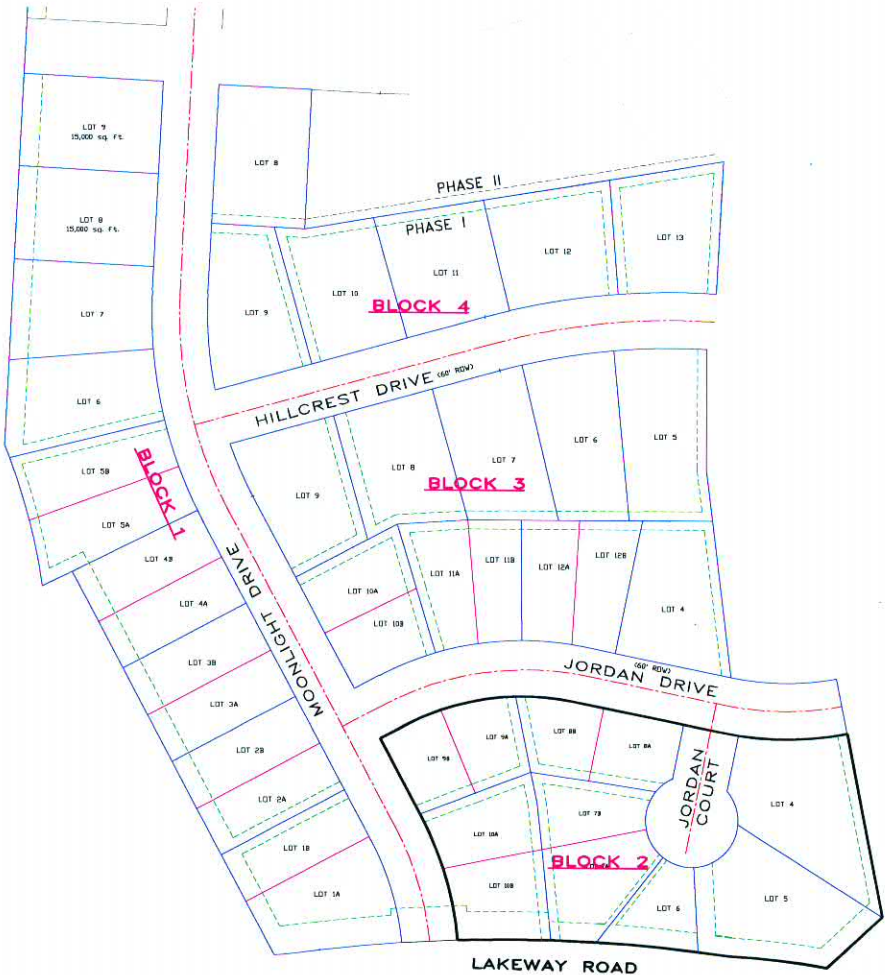
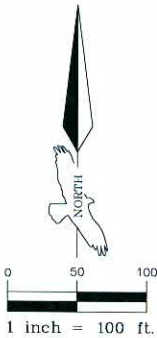
