City Administrator Napier explained that the approach Mr. Albers is suggesting would make it difficult, from a cost planning perspective, to maintain rates at a consistent and competitive level. All enterprises have fixed costs, and without understanding where those costs would be made up, i.e., a fixed base of customers, then the variability rate by which the service is charged becomes much more volatile and less dependent. A rate when the base is not consistent has a greater chance of fluctuating year to year. He went on to say that the private haulers are aware of these changes and are supportive. After the discussion, roll was called on the motion with the following results. Council Members voting aye: Carsrud, Carter-King, Jerred, Kuntz, McGrath, Rothleutner, and Mayor Opseth. The Presiding Officer declared the motion carried.

Councilwoman Carter-King recognized Barbara Bonds for her efforts and hard work in obtaining the bond and stated that she was invaluable during this process. She then asked City Administrator Napier to explain the AA-rating the City received and how this rating reflects the City, what it saved the city, and selling of the bonds. Mr. Napier explained the rating is considered an upper medium grade and having this rating saved the City in terms of added costs. He then reported that 25% of the bonds were sold locally. It was moved by Councilwoman Carter-King and seconded by Councilman Rothleutner to approve a bid award for a substation transformer for the Swanson Substation Expansion to HD Supply (representing CG Group) in the amount of \$408,919.41. Mayor Opseth asked for discussion. There was none. Roll was called on the motion with the following results. Will Zilka spoke to the Council in regard to the tract of land behind his property and suggested that if he didn't have to pay for the property, he would consider it a wash since he has maintained this 20' portion of property for seven years at his own expense. City Administrator Napier explained that the plan is to sell the property at the appraised value to any of the property owners that were interested. Mr. Napier went on to say that municipalities are required to have an appraisal on any property that they want to dispose of, and added that there is a \$500 threshold that gives the Council flexibility of what they would like to do with the land. Mr. Napier then expressed concern that the area has not been maintained. The City has received three (3) bills this summer from a contractor who indicated that he has mowed this property.
