## RESOLUTION NO.

## A RESOLUTION PROVIDING FOR THE EXTENSION OF THE BOUNDARIES OF THE CITY OF GILLETTE, WYOMING, AND ANNEXATION OF A TRACT OF LAND KNOWN AS THE BILLY BOB ANNEXATION CONTIGUOUS AND ADJOINING THE PRESENT BOUNDARIES

WHEREAS, the majority of the landowners owning a majority of the land described in Exhibit "B" have petitioned this Council for Annexation of said land to the City of Gillette, Campbell County, Wyoming, and

BE IT RESOLVED by the Governing Body of the City of Gillette, Wyoming:

1. That an Annexation of the area is for the protection of the health, safety and welfare of the persons residing in the area and in the City;

2. That the urban development of the area sought to be annexed would constitute a natural, geographic, economical and social part of the City;

3. That the area sought to be annexed is a logical and feasible addition to Gillette, and that the extension of basic services such as water and sewer systems, police and fire protection and other services customarily available to residents of this City, can reasonably be furnished to the area proposed to be annexed, it being understood that the Petitioners shall be financially responsible for the extension and construction of said water and sewer services;

4. That the area sought to be annexed is contiguous with or adjacent to the City of Gillette;

5. That the area sought to be annexed known as the Billy Bob Annexation is more particularly described as follows:

## Legal Description – Billy Bob Annexation

A tract of land located in the NW1/4 NW1/4 and the NE1/4 NW1/4 of Section 35, T50N,R72W of the Sixth Principal Meridian, Campbell County, Wyoming. Said tract of land being described more particularly as follows:

Beginning at a point on the North line of said Section 35 from which the NW section corner of said Section 35 lies S89<sup>°</sup>34'00"W a distance of 1040.00 feet;

Thence N89 $^{\circ}$ 34'00"E along the North line of said Section 35 a distance of 310.30 feet; thence S00 $^{\circ}$ 09'00"W a distance of 261.28 feet;

thence S89°34'00"W a distance of 104.30 feet;

thence S00<sup>°</sup>09'00"W a distance of 190.13 feet to the North right of way of Country Club Road;

thence along the said North right of way of Country Club Road N77<sup>°</sup>53'17"W a distance of 89.43 feet;

thence Northwesterly along the said North right of way of Country Club Road a curve to the left through a central angle of  $03^{\circ}35'34''$  with a radius of 1903.26 feet an arc distance of 119.34 feet and with a chord that bears N79<sup>°</sup>40'54''W a chord distance of 119.32 feet;

thence N00°00'00"E a distance of 409.71 feet to the POINT OF BEGINNING.

6. That the City has sent by certified mail to all landowners within the territory a summary of the proposed Annexation Report as required under W. S. 15-1-402 (c) and notice of the time, date and location of the public hearing required by W. S. 15-1-405(a).
