### A RESOLUTION AUTHORIZING SUBMISSION OF APPLICATION TO THE WYOMING BUSINESS COUNCIL UNDER THE BUSINESS READY COMMUNITY GRANT AND LOAN PROGRAM FOR A PLANNING PROJECT ON BEHALF OF THE GOVERNING BODY OF THE CITY OF BUFFALO, WYOMING

FOR THE PURPOSE OF: TRI-CITY REGIONAL MARKETING INIATIVE

#### WITNESSETH

**WHEREAS**, the Governing Body of the City of Buffalo desires to participate in the Business Ready Community Grant and Loan Program to assist in financing this project; and

**WHEREAS**, the Governing Body of the City of Buffalo recognizes the need for collaborative regional economic development and marketing efforts between the communities of Buffalo, Gillette, and Sheridan, setting apart and distinguishing the northeastern region of Wyoming as a desirable location to do business, and believes this project will address those needs; and

**WHEREAS**, the public benefit(s) of this project will be promoting the three communities and their surrounding areas based on their unique competitive advantages and resources; and the consideration is the creation of tailored marketing messages and materials for the communities, and developing a strategy and framework for increasing capacity to effectively market the communities as a cohesive region; and

**WHEREAS**, the specific goals and measures of success of this project are the development of a regional brand and marketing message, and the creation of a strategy and action plan for deploying the regional marketing message and effectively responding to leads generated by regional marketing efforts; and

**WHEREAS**, the Business Ready Community Grant and Loan Program requires that certain criteria be met, as described in the Wyoming Business Council's Rules governing the program, and to the best of our knowledge this application meets those criteria; and

**WHEREAS**, the Governing Body of the City of Buffalo plans to provide a share of the \$33,334 cash match to this Business Ready Community Grant and Loan Program Planning project from the following source(s):

**\$8,000 coming from the City's General Fund Budget;** and

**WHEREAS,** In the event of any project cost overruns, the cities of Buffalo, Gillette, and Sheridan will share the additional costs and provide funding in the amount necessary to complete the project utilizing appropriate general funds identified in each community for professional services expenditures; and

**WHEREAS,** the Governing Body for the City of Buffalo has considered other possible funding solutions for this project which included professional services funds of the City, further grant opportunities, and other local funding set aside for economic development; and

**WHEREAS,** the City of Buffalo is working in partnership with the Cities of Gillette and Sheridan, as well as the KBJ Economic Development Joint Powers Board; and

**WHEREAS,** the City of Buffalo held a public hearing on **[MONTH, DAY, YEAR]** to solicit testimony from citizens and gave full consideration to all comments received; and

**BE IT FURTHER RESOLVED,** the KBJ Economic Development Joint powers Board is hereby designated as the authorized representatives of the City of Buffalo to act on behalf of the Governing Bodies of Buffalo, Gillette and Sheridan on all matters relating to this grant application.
