ORDINANCE NO.

AN ORDINANCE AMENDING GILLETTE CITY CODE SECTIONS 17-6.A.1, 17-6.B.1, 17-6.C.1, 17-6.D.1, AND 17-6. E.1, TO REVISE RATES FOR ELECTRICAL SERVICE SUPPLIED BY THE CITY OF GILLETTE.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GILLETTE, WYOMING:

SECTION ONE. Section 17-6.A.1. of the Gillette City Code is amended to read as follows:

1. The rates to be charged for domestic purposes shall be as follows:

(a) For bills dated before May 1,  $\frac{20142015}{2015}$ :

(i) Each customer shall pay a monthly Customer Charge of  $\frac{17.8518.85}{18.85}$ ; and

(ii) Additionally, each customer shall pay \$0.07450 <u>0815</u>
<u>07815</u> per kilowatt hour used per month as an Energy Charge.
(Ord.3032, 3-16-98)

(b) For bills dated after May 1, 20142015:
(i) Each customer shall pay a monthly Customer Charge of \$18.8520.35; and
(ii) Additionally, each customer shall pay \$0.07815-0825 per kilowatt hour used per month as an Energy Charge. (Ord.3032, 3-16-98)

SECTION TWO. Section 17-6.B.1. of the Gillette City Code is amended to read as follows:

1. The rates for domestic purposes in approved All-Electric private dwellings shall be as follows:

(a) For bills dated before May 1, 20142015:

(i) Each customer shall pay a monthly Customer Charge of  $\frac{17.8518.85}{18.85}$ ; and

(ii) Additionally, each customer shall pay \$0.07450-07815
per kilowatt hour per month as an Energy Charge. (Ord.3032, 3-16-98)

(b) For bills dated after May 1,  $\frac{20142015}{2015}$ :

(i) Each customer shall pay a monthly Customer Charge of  $\frac{18.8520.35}{20.35}$ ; and

(ii) Additionally, each customer shall pay \$0.07815-0825 per kilowatt hour per month as an Energy Charge. (Ord.3032, 3-16-98)

SECTION THREE. Section 17-6.C.1. of the Gillette City Code is amended to read as follows:

1. The rates to be charged for commercial and miscellaneous purposes shall be as follows:

(a) For bills dated before May 1, 20142015:
(i) Each customer shall pay a monthly Customer Charge of \$28.0029.00; and
(ii) Additionally, each customer shall pay \$0.07460-0787 per kilowatt hour per month as an Energy Charge. (Ord.3032, 3-16-98)

(b) For bills dated after May 1, 20142015:
(i) Each customer shall pay a monthly Customer Charge of \$29.0031.50; and
(ii) Additionally, each customer shall pay \$0.0787\_081\_per kilowatt hour per month as an Energy Charge. (Ord.3032, 3-16-98)

SECTION FOUR. Section 17-6.D.1. of the Gillette City Code is amended to read as follows:

D. Optional Small Commercial and Miscellaneous Service Rate.

1. The Rates to be charged for the Optional Small Commercial and Miscellaneous Service Rate shall be as follows:

(a) For bills dated before May 1, 20142015:

(i) Each customer shall pay a monthly Customer Charge of  $\frac{17.8519.00}{317.85}$ ; and

(ii) Additionally, each customer shall pay \$0.0985–103 per kilowatt hour for all energy used per month as an Energy Charge.

(c) For bills dated after May 1, 20142015:
(i) Each customer shall pay a monthly Customer Charge of \$1920.35; and
(ii) Additionally, each customer shall pay \$0.103-109 per kilowatt hour for all energy used per month as an Energy Charge.

SECTION FIVE. Section 17-6.E.1. of the Gillette City Code is amended to read as follows:

E. General Service Rate.

1. The rates to be charged for those customers with demand meters shall be as follows:

(a) For bills dated before May 1,  $\frac{20142015}{2015}$ :

(i) Each customer shall pay a monthly Customer Charge of 6063.00; and

(ii) Additionally, each customer shall pay \$0.0430.04519 per kilowatt hour per month as an Energy Charge; and

(iii) Additionally, each customer shall pay a monthly demand charge of \$8.30.70 per kilowatt month as shown or computed from the readings of the City's demand meter installed at the customer's location for the 15 minute period of customer's greatest use during the billing period. (Ord.3032, 3-16-98)

(b) For bills dated after May 1, 20142015:

(i) Each customer shall pay a monthly Customer Charge of  $\frac{6370.00}{3}$  and

(ii) Additionally, each customer shall pay \$0.04519\_0492 per kilowatt hour per month as an Energy Charge; and

(iii) Additionally, each customer shall pay a monthly demand charge of \$8.70 per kilowatt month as shown or computed from the readings of the City's demand meter installed at the customer's location for the 15 minute period of customer's greatest use during the billing period. (Ord.3032, 3-16-98)
