It was moved by Councilman Rothleutner and seconded by Councilman Carsrud to approve the foregoing Ordinance on third and final reading. Mayor Carter-King asked for discussion. Tim Hocum asked if other businesses are required to have background checks. City Clerk Abelseth confirmed that itinerant merchants are required to have background checks. Mr. Hocum asked if other businesses are required to provide Wyoming Worker's Compensation and Unemployment Insurance. City Attorney Anderson confirmed that contractors are required to provide this information. After the discussion, roll was called on the motion with the following results. Council Members voting aye: Rothleutner, Barks, Carsrud, Jerred, Kuntz, McGrath, and Mayor Carter-King. The Presiding Officer declared the motion carried.

Roll was called on the motion with the following results. Council Members voting aye: Barks, Carsrud, Jerred, Kuntz, McGrath, Rothleutner, and Mayor Carter-King. The Presiding Officer declared the motion carried.

Ordinance First Reading

ORDINANCE 15-08

AN ORDINANCE TO REVISE CHAPTER 14 OF THE GILLETTE CITY CODE TO
ENACT §14-19 ENTITLED *MARIJUANA USE AND POSSESSION, DEFINITIONS,
AND PENALTIES*

It was moved by Councilman Carsrud and seconded by Councilman McGrath to approve the foregoing Ordinance on first reading. Mayor Carter-King asked for an explanation regarding the request. City Administrator Napier explained that the change pertains to misdemeanor marijuana offenses that will be heard in Municipal Court. After the explanation, roll was called on the motion with the following results. Council Members voting aye: Carsrud, Jerred, Kuntz, McGrath, Rothleutner, Barks, and Mayor Carter-King. The Presiding Officer declared the motion carried.

New Business

It was moved by Councilman Rothleutner and seconded by Councilman Jerred to approve three (3) catering permits for the Donkey Creek Music Festival on June 26th - June 28th from 10:00 a.m. to 10:00 p.m., requested by Prime Rib Restaurant. Mayor Carter-King asked for discussion. There was none. Roll was called on the motion with the following results. Council Members voting aye: Jerred, Kuntz, McGrath, Rothleutner, Barks, Carsrud, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman Carsrud and seconded by Councilman Jerred to approve the extension of the serving area at Los Compadres Mexican Restaurant to include the front patio. Mayor Carter-King asked for discussion. Councilman Barks asked for the dimensions of the patio area. Oswaldo Santana, General Manager, explained that the area is 16' X 70" and stated there are three (3) ramps accessing the patio area. Their intention is to extend onto one of the ramps and install a gate. After the discussion, roll was called on the motion with the following results. Council Members voting aye: Kuntz, McGrath, Rothleutner, Barks, Carsrud, Jerred, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman Jerred and seconded by Councilman Kuntz to accept public improvements for the Wastewater Treatment Facility (WWTF) Drainage Replacement Project, installed by Powder River Construction, Inc., in the amount of \$387,367.17 (1% Project). Mayor Carter-King asked for an explanation regarding the request. City Administrator Napier explained this is the floor drain project at the Wastewater Treatment Facility. After the explanation, roll was called on the motion with the following results. Council Members voting aye: McGrath, Rothleutner, Barks, Carsrud, Jerred, Kuntz, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman Jerred and seconded by Councilman Rothleutner to approve a bid award for the Gillette Regional Water Supply Project Phase I extensions to Redpoint Contracting in the amount of \$5,580,150. Mayor Carter-King asked for an explanation regarding the request. City Administrator Napier explained the forward motion of regional connections regarding the Madison Project. He added that this project will extend water to Cook Road, Bennor Estates, Overbrook, Rafter D, Spring Hill Ranch, Southfork, and Antelope Valley Districts. After the explanation, roll was called on the motion with the following results. Council Members voting aye: Rothleutner, Barks, Carsrud, Jerred, Kuntz, McGrath, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman Carsrud and seconded by Councilman Jerred for the rejection of all bids for the Gillette Madison Pipeline Project Contract #06. Mayor Carter-King asked for an explanation regarding the request. City Administrator Napier explained that this project consists of the installation of a 300,000 gallon water storage tank needed for the construction of the Madison Pipeline. He added there was only one bid received for this project and that bid was significantly over budget. Because of this, staff is recommending that the bid be rejected to give staff the opportunity to re-work the bidding documentation and rebidding the project at a later date. After further discussion, roll was called on the motion with the following results. Council Members voting aye: Barks, Carsrud, Jerred, Kuntz, McGrath, Rothleutner, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman Carsrud and seconded by Councilman Jerred for the rejection of all bids for the Gillette Madison Pipeline Phase III Rehabilitation Project (1% Project). Mayor Carter-King asked if this would be the same explanation as to the previous request regarding the rejection of bids. City Administrator Napier confirmed it was, however, in this scenario, the project is to install a cathodic protection system on the existing pipe. Again, there was only one bid received that was significantly higher than what was budgeted. Staff would like to

re-work the bidding documentation, rebidding the project at a later date. After the discussion, roll was called on the motion with the following results. Council Members voting aye: Carsrud, Jerred, Kuntz, McGrath, Rothleutner, Barks, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman Rothleutner and seconded by Councilman Barks to approve a bid award for the Pavement Management System 2015 Schedule B Project to S&S Builders, LLC, in the amount of \$1,013,228 (1% Project). Mayor Carter-King asked for an explanation regarding the request. City Administrator Napier explained the project, the areas affected, and the engineer's estimate. After the explanation, roll was called on the motion with the following results. Council Members voting aye: Jerred, Kuntz, McGrath, Rothleutner, Barks, Carsrud, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman Jerred and seconded by Councilman Rothleutner to approve a professional services agreement for construction management associated with the Pavement Management System 2015 Schedule B Project with PCA Engineering, Inc., in the amount of \$127,518 (1% Project). Mayor Carter-King asked for an explanation regarding the request. City Administrator Napier explained that this request pertains to the construction management oversight of the previously discussed project. After the explanation, roll was called on the motion with the following results. Council Members voting aye: Kuntz, McGrath, Rothleutner, Barks, Carsrud, Jerred, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman Rothleutner and seconded by Councilman Jerred to approve a bid award for the alternative bid schedule and additive bid 1 for the School Zone Crossings Phase I Project to Powder River Construction, Inc., in the amount of \$250,538.75 (1% Project). Mayor Carter-King asked for an explanation regarding the request. City Administrator Napier explained that the proposal includes 15 pedestrian crossings needing improvements, along with a portion of sidewalk along the east side of Gurley Avenue that would provide a walking path for students attending the new Lakeview School. After the explanation, roll was called on the motion with the following results. Council Members voting aye: McGrath, Rothleutner, Barks, Carsrud, Jerred, Kuntz, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman Rothleutner and seconded by Councilman Carsrud to approve a professional services agreement for construction management associated with the Fox Park - Park Improvements and Arley Acres Pathway Project with Environmental and Civil Solutions, LLC, in the amount of \$59,900 (1% Project). Mayor Carter-King asked for an explanation regarding the request. City Administrator Napier explained this will be the construction management oversight for the park improvements as well as the pathway improvements. After the explanation, roll was called on the motion with the following results. Council Members voting aye: Rothleutner, Barks, Carsrud, Jerred, Kuntz, McGrath, and Mayor Carter-King. The Presiding Officer declared the motion carried.
