There was none. Roll was called on the motion with the following results. Council Members voting aye: McGrath, Rothleutner, Barks, Carsrud, Jerred, Kuntz, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman Rothleutner and seconded by Councilman Jerred to approve a catering permit for June 12, 2015, beginning at 8:00 p.m. to 2:00 a.m. for a Mixed Martial Arts (MMA) After Party that will include a beer garden and outdoor music (music ending at midnight) requested by Tower West Lodge. Mayor Carter-King asked for discussion. Councilman Jerred asked if this is similar to what is approved for Mingles. City Clerk Abelseth affirmed it is similar. After the discussion, roll was called on the motion with the following results. Council Members voting aye: Rothleutner, Barks, Carsrud, Jerred, Kuntz, McGrath, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman Rothleutner and seconded by Councilman Kuntz to approve an agreement to allow for the purchase of 3 megawatts of hydropower with Western Area Power Administration (WAPA) from October 1, 2024 through September 30, 2054, and authorizing the Mayor to execute the agreement on behalf of the City of Gillette. Mayor Carter-King asked for discussion. There was none. Roll was called on the motion with the following results. Council Members voting aye: Barks, Carsrud, Jerred, Kuntz, McGrath, Rothleutner, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman Rothleutner and seconded by Councilman McGrath to approve Amendment No. 4 for the project agreement for the Gillette Madison Pipeline Joint Bonding Project to extend the project completion date to July 1, 2016, with the State of Wyoming Water Development Commission (WWDC). Mayor Carter-King asked for discussion. There was none. Roll was called on the motion with the following results. Council Members voting aye: Carsrud, Jerred, Kuntz, McGrath, Rothleutner, Barks, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman Rothleutner and seconded by Councilman Barks to approve Amendment No. 6 to the 2009 Project Funding Agreement for grant funding for the Gillette Madison Pipeline Project with the State of Wyoming Water Development Commission (WWDC) in the amount of \$12,406,005 as authorized by the 2015 Wyoming State Legislature. Mayor Carter-King asked for an explanation regarding the request. City Administrator Napier explained that this is the sixth amendment of the project allowing the funds to be used. This will be the last agreement, securing the funds from the State. After the discussion, roll was called on the motion with the following results. Council Members voting aye: Jerred, Kuntz, McGrath, Rothleutner, Barks, Carsrud, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman Rothleutner and seconded by Councilman Jerred to pre-qualify pipeline contractors for formal bidding purposes for the Gillette Madison Project Contract No. 4e. Mayor Carter-King asked for an explanation regarding the request. City Administrator Napier explained that this is a pre-qualification project and, in this particular instance, this will be 12 mile, 42" transmission line, connecting Moorcroft to Pine Ridge. After the discussion, roll was called on the motion with the following results. Council Members voting aye: Kuntz, McGrath, Rothleutner, Barks, Carsrud, Jerred, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman Carsrud and seconded by Councilman Rothleutner to approve a professional services agreement for construction management associated with the Westover Road Improvements Project with PCA Engineering, Inc., in the amount of \$165,625 (1% Project). Mayor Carter-King asked for an explanation regarding the request. City Administrator Napier explained the project and the engineer's estimate. After the discussion, roll was called on the motion with the following results. Council Members voting aye: McGrath, Rothleutner, Barks, Carsrud, Jerred, Kuntz, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman Jerred and seconded by Councilman Kuntz to approve a maintenance agreement for the Wyodak East and West Project (Hwy 51 Pathway) between the Wyoming Department of Transportation and the City of Gillette. Mayor Carter-King asked for discussion. There was none. Roll was called on the motion with the following results. Council Members voting aye: Rothleutner, Barks, Carsrud, Jerred, Kuntz, McGrath, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman Jerred and seconded by Councilman Carsrud to approve a request from Campbell County, Wyoming, for the City of Gillette to contribute water and sewer plant investment fees, electrical capital contribution fees, and building permit fees on behalf of Campbell County, for the College Education and Activity Center Project in the amount of \$56,269. Mayor Carter-King asked for discussion. Councilman Kuntz informed the public that even though the City is contributing the various fees to the County, there is still a cost to the City for the contribution of these fees. Roll was called on the motion with the following results. Council Members voting aye: Barks, Carsrud, Jerred, Kuntz, McGrath, Rothleutner, and Mayor Carter-King. The Presiding Officer declared the motion carried.

Administrator's Report

Mayor Carter-King asked for an Administrator's report. City Administrator Napier reported there was no report.

Special Orders of the Day

Mayor Carter-King opened into a public hearing to consider a land trade with Lang Homes, Inc. City Attorney Anderson explained that this is a land trade of two portions of land on Burma Road to Lang Homes, Inc., in exchange for the right-of-way on Beaver Drive. Council approved an agreement in March 2012 to do the land trade once the parcels were legally described; this has happened and there will be a plat that will be recorded. After the discussion, Mayor Carter-King closed the public hearing.

Roll was called on the motion with the following results. Council Members voting aye: Jerred, Kuntz, McGrath, Rothleutner, Barks, Carsrud, and Mayor Carter-King. The Presiding Officer declared the motion carried.

Mayor Carter-King opened into a public hearing for an Ordinance to amend the zoning Ordinance of the City of Gillette, Wyoming, to allow residential occupancy in permanent and mobile residential dwelling units for caretakers under certain conditions in the R-R, Rural Residential District. City Administrator Napier explained that the petitioner is requesting an amendment, in the form of a text addition, into the code that would allow for secondary residential accessory use of a single family dwelling area to be permitted. In this particular case, the suggestion is that it be made available for caretaker kinds of services, secondary to the primary living unit in the subject area, in an R-R zoning classification. It should be noted that staff is not in support of this particular consideration of expanding the code to allow for this type of application. The Planning Commission considered this request as well, and voted against the request on a 3 to 2 basis. Councilman Jerred asked if the Board of Adjustments would be in favor of the request as it doesn't meet specific criteria. Mr. Napier stated that given the cursory review of requirements, that typically the Board of Adjustments would consider for a variation of this nature, in his opinion, would not be able to grant the variance because of the inability to meet the criteria required by the BOA. If the BOA does not allow for a variance, then the petitioner could approach the BOA by virtue of a permitting process that they would initiate with the building department. If the BOA does not grant the variance, then the next alternative for the petitioner would be District Court. Mayor Carter-King asked staff to give a short summation regarding their recommendation against the approval for the request. Development Services Director Hamilton stated that staff is against the request due to the fact that in any residential zoning district in the city, residential occupancy is not a permitted accessory use. Staff sees this as

opening a door to other opportunities. The applicant has proposed, as part of the criteria for the text amendment, that the lot in question would have to be a minimum of two acres. Kelly Gangestad, explained the reasoning behind his request. He stated that he received a letter from the Planning Division notifying him that he was not in compliance with residential occupancy. He explained the size of the lots and the need for some residents in this area to have someone come and take care of their lot. He suggested several changes that Council could consider for changes to the ordinance. Councilman McGrath asked how long he intended to live here. Mr. Gangestad stated that his preference would be two to two and half years. After that time, he believes that the owner of the property would sell. Jacquie Ary, owner of the property, explained that due to her age, she does not anticipate living in the residence any longer than two and half years. Discussion of Mr. Gangestad living in an RV Park rather than on her property took place. After further discussion, Mayor Carter-King stated that changing the zoning is a complicated process. Not only is staff recommending the denial of the request, but the Planning Commission also voted against the request. Mayor Carter-King added that there are other choices such as the Gangestad's moving into the home, or moving their RV to an RV Park; there is also the option of approaching the BOA. She added that the Council considers changing the zoning very seriously as it affects the whole city. Councilman Kuntz asked if staff is aware of an ordinance in another city or town that allows for, or doesn'tallow for, this type of use. City Attorney Anderson stated that he is not aware of any ordinance allowing this, and added that $\mbox{RV}'\,\mbox{s}$ are not allowed as primary dwelling units in the city, outside of RV Parks and for short-term, exceptional uses in mobile home parks. After further discussion, Mayor Carter-King closed the public hearing.

AN ORDINANCE TO AMEND THE ZONING ORDINANCE OF THE CITY OF GILLETTE, WYOMING, TO ALLOW RESIDENTIAL OCCUPANCY IN PERMANENT AND MOBILE RESIDENTIAL DWELLING UNITS FOR CARETAKERS UNDER CERTAIN CONDITIONS IN THE R-R, RURAL RESIDENTIAL DISTRICT, SUBJECT TO ALL PLANNING REQUIREMENTS

It was moved by Councilman Rothleutner and seconded by Councilman McGrath to approve the foregoing Ordinance. Mayor Carter-King asked for discussion. There was none. Roll was called on the motion with the following results. Council Members voting nay: Kuntz, McGrath, Rothleutner, Barks, Carsrud, Jerred, and Mayor Carter-King. The Presiding Officer declared the motion denied.

Mayor Carter-King opened into a public hearing to receive input on the sale of used property to Campbell County Health. City Administrator Napier explained that this is a police car that is no longer in use and will be used for transportation purposes only, not used or marked as an emergency vehicle. After the discussion, Mayor Carter-King closed the public hearing.

Mayor Carter-King asked for discussion. There was none. Roll was called on the motion with the following results. Council Members voting aye: McGrath,

Rothleutner, Barks, Carsrud, Jerred, Kuntz, and Mayor Carter-King. The Presiding Officer declared the motion carried.

Mayor Carter-King opened into a public hearing to consider the Gillette City Budget for FY2015-2016. City Administrator Napier explained the upcoming budget for FY2015-2016. In his estimation this is a conservative budget and this is the first of three readings. Council thanked staff for their efforts in creating a conservative budget. After the discussion, Mayor Carter-King closed the public hearing.

It was moved by Councilman Kuntz and seconded by Councilman McGrath to approve the foregoing Ordinance. Mayor Carter-King asked for discussion. Councilman Rothleutner stated that he supports the budget, however, he will be abstaining from all budget matters pertaining to personnel. After the discussion, roll was called on the motion with the following results. Council Members voting aye: Rothleutner voted aye, however, abstained from budget matters pertaining to personnel, Barks, Carsrud, Jerred, Kuntz, McGrath, and Mayor Carter-King. The Presiding Officer declared the motion carried.
