Councilman Kuntz stated that the "S" curve on Boxelder has been an issue for as long as he has served on the City Council, and he is glad to see that the issue will finally be resolved. Councilman Barks stated that the issue will not necessarily be resolved quickly. City Administrator Napier stated that there is a lot of work to be done in order to complete the project as it relates to straightening the "S" curve in the area. Acquiring the land will be one of the first steps, obtaining the right-of-ways will allow the building of the footprint to alleviate the "S" curve. After the discussion, roll was called on the motion with the following results. Council Members voting aye: Barks, Carsrud, Jerred, Kuntz, Rothleutner, and Mayor Carter-King. The Presiding Officer declared the motion carried.

Appointments

It was moved by Council President Rothleutner and seconded by Councilman Barks to appoint Jim Hloucal to the Retiree Health Benefit & Trust Committee. Mayor Carter-King asked for discussion. There was none. Roll was called on the motion with the following results. Council Members voting aye: Carsrud, Jerred, Kuntz, Rothleutner, Barks, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Council President Rothleutner and seconded by Councilman Jerred to appoint R. T. Cox to serve a third full term on the Board of Adjustment; Jessica Klym to serve a partial term on the Mayor's Art Council; Adrian Gerrits and Glen Asay to serve full terms on the Parks & Beautification Board; Clark Sanders to serve a second full term on the Planning Commission; and Keith Chrans to serve a second full term on the Urban Systems Committee. Mayor Carter-King asked for discussion. Councilman Jerred asked if there was another opening on the Planning Commission. Development Services Director Hamilton stated that there are two vacant

positions on the Planning Commission. Mayor Carter-King thanked the appointees for volunteering their time to serve on the boards. After the discussion, roll was called on the motion with the following results. Council Members voting age: Jerred, Kuntz, Rothleutner, Barks, Carsrud, and Mayor Carter-King. The Presiding Officer declared the motion carried.

Administrator's Report

Mayor Carter-King asked for an Administrator's report. City Administrator Napier reported there was no report.

Special Orders of the Day

Mayor Carter-King opened into a public hearing Pursuant to Wyoming Statutes 15-1-112 (b) (i) (B), to discuss the conveyance of the site of the Education and Activities Center for the Gillette College, to Campbell County, Wyoming. City Administrator Napier stated that this is a good example of the partnership that has built so many of the features in this community that the County, the College, and the City are undertaking. The City is being asked to convey almost 11.5 acres to the ownership of the County. The County will then construct the education activity center, and the College will operate and maintain the facility on behalf of the three entities. Councilman Jerred asked for the estimated value of the land. City Administrator Napier stated that the value of the land is approximately 3 million dollars. Councilman Kuntz reiterated that the City's contribution to this project will include approximately 3 million dollars in the value of the land in addition to the contribution of the plant investment fees previously approved for the project. Mayor Carter-King agreed with Councilman Kuntz and stated that the City has also agreed to contribute funding for student housing. Mayor Carter-King closed the public hearing.

RESOLUTION 2523

A RESOLUTION TO AUTHORIZE THE CONVEYANCE OF AN 11.46 ACRE TRACT OF LAND, THE SITE OF THE EDUCATION AND ACTIVITIES CENTER FOR THE GILLETTE COLLEGE, TO CAMPBELL COUNTY, WYOMING, FOLLOWING A PUBLIC HEARING ADVERTISED IN A PUBLISHED NOTICE

It was moved by Councilman Rothleutner and seconded by Councilman Carsrud to approve the foregoing Resolution authorizing the conveyance of an 11.46 acre tract of land, the site of the Education and Activities Center for the Gillette College, to Campbell County, Wyoming. Mayor Carter-King asked for discussion. There was none. Roll was called on the motion with the following results. Council Members voting aye: Kuntz, Rothleutner, Barks, Carsrud, Jerred, and Mayor Carter-King. The Presiding Officer declared the motion carried.

Mayor Carter-King opened into a public hearing for the zoning map amendment for a portion of Lot A2, Tract M, Sunburst Subdivision No. 3, from M-H, Mobile Home District, to C-1, General Commercial District. City Administrator Napier explained that the basic idea for the request is to allow for the transaction to a C-1 property to create a more effective use of the property. In the near future, a subdivision request will come forward to adjust the property line for use as a commercial property. After the explanation, Mayor Carter-King closed the public hearing.

ORDINANCE 15-14

AN ORDINANCE TO AMEND THE DISTRICT ZONING MAP OF THE CITY OF GILLETTE, WYOMING, FOR A PORTION OF LOT A2, TRACT M, SUNBURST SUBDIVISION NO. 3, FROM M-H, MOBILE HOME DISTRICT, TO C-1, GENERAL COMMERCIAL DISTRICT, SUBJECT TO ALL PLANNING REQUIREMENTS

It was moved by Councilman Jerred and seconded by Councilman Carsrud to approve the foregoing Ordinance on first reading. Mayor Carter-King asked for discussion. There was none. Roll was called on the motion with the following results. Council Members voting aye: Rothleutner, Barks, Carsrud, Jerred, Kuntz, and Mayor Carter-King. The Presiding Officer declared the motion carried.

Mayor Carter-King opened into a public hearing for a zoning map amendment for a portion of Tract 2C, Energy Park Third Addition, from M-H, Mobile Home, to C-1, General Commercial. Mayor Carter-King asked for discussion. Charlie Madsen, resident of Cherry Lane, expressed concerns regarding the possibility of opening Cherry Lane into Spruce Lane to allow access to the property in question. Development Services Director Hamilton explained that the extension of Cherry Lane would require the acceptance of a right-of-way, the approval of a subdivision plat, and would then allow a residential street to run through an existing dedicated park. Director Hamilton felt that the chances of the extension of Cherry Lane were pretty slim and would require the approval of City Council. Mr. Madsen also expressed concerns with drainage in the area. Director Hamilton stated that any development would have to address the drainage conveyance due to the increase of impervious surface. Councilman Barks asked if the drainage would flow south. Director Hamilton stated that the drainage on this site would actually go north. Councilman Jerred asked if the agent for the land was present. Dick Doyle of Doyle surveying was present to represent the developer, Kanti Patel. Councilman Jerred asked the intent of the proposed use of the property. Mr. Doyle stated that the proposed use would be commercial storage. Councilman Jerred stated that the size and the location of the property restrict the use of the property, but he expressed concern that the C-1 designation has several pages of possible property uses. Mr. Doyle indicated that they would be willing to notate on the plat that the property would be limited to use for commercial storage and limited driveways. Councilman Barks verified with Mr. Doyle that the developer would indeed be willing to notate on the plat the restrictions of use and driveway access. Mr. Doyle agreed with the restrictions. Nancy Hagen, resident of Cherry Lane, expressed concerns with the designation of the property as commercial. She stated concern about losing the bike path in the area; school children use the bike path to reach the park area and cut through the park to access Lake View School. She also expressed concerns with the fact that there has been no definitive answer to questions regarding the distance between the existing home on the end of Cherry Lane, the commercial property, and Spruce Lane. Mayor Carter-King asked City Administrator Napier to address the walking path concerns. City Administrator Napier stated that the walking path would not be affected with the development of the property. Ms. Hagen felt that if access would be allowed from Spruce Lane, it would directly affect the walking path. Director Hamilton stated that the pathway would remain, but the pedestrians would be required to cross the driveways, just as they would any other residential or commercial driveways; the pathway is in the right-of-way. Director Hamilton stated that access from Warlow would not be allowed due to spacing requirements; access would be limited to Spruce Lane. Councilman Jerred asked if this was a zoning change that would be approved on a future plat. Director Hamilton stated that the plat has been approved by Council, but property access is not addressed on the plat and would be addressed with the development of the property and would be permitted through the City Engineer's Office to ensure

that it meets spacing requirements. Depending on the quantity and size of the storage units it may require a development plan, which is approved by the Planning Commission. Councilman Barks asked if there would be the potential of 15-20 mobile homes on the site with each driveway crossing the pathway, if the property was developed as it is currently zoned. Director Hamilton stated that mobile homes would be required to have shared access to driveways, with the potential of at least 10 driveways crossing the pathway. He also stated that a commercial designation would potentially limit the driveway access to 2 or 3. Fred Isaack, Sr., resident of Pathfinder Circle, expressed drainage concerns due to the marshy area. Director Hamilton reiterated that offsite flows would be addressed upon development review. Councilman Barks stated that an engineer study would be done prior to developing the property to determine the water flows, and issues would be addressed. Fred Isaack, Jr., resident of Pathfinder Circle asked if the property use restriction was notated on the plat and the property was sold, would the restriction still apply. Councilman Jerred replied that the notation would remain with the plat and, therefore, the restrictions would still apply to the property. Mayor Carter-King asked for verification. City Attorney Anderson stated that covenants could be prepared and dedicated on the plat to limit the use of the land and state the terms and conditions to change the use of the property. Fred Isaack, Jr. stated that they do not want development of any commercial property that would include heavy traffic and large commercial vehicles in their neighborhood. He also stated that he was still unsure as to whether the restrictions would apply if the property was sold. City Attorney Anderson stated that action would be taken to make it a condition of the plat. Holly Galloway, a resident in the neighborhood, stated concern that no written notification of the proposed zone change was sent to residents in the area; her only notification was a blue sign placed on site. City Administrator Napier explained the City's notification process: 1) Written communication to all residents within a specified perimeter of the property in question; 2) Conspicuous posting on site; 3) Publication in the newspaper. Director Hamilton added that the perimeter includes 140 feet, excluding right-of-ways. In this instance, two (2) lots on Cherry Lane were within the perimeter requiring written notification. City Administrator Napier stated that the means of notification are specified in City Ordinance, which reflects statutory obligations. Ms. Galloway asked for the Planning Commission vote. Mayor Carter-King informed her that the vote was 4/0 in favor of the zone change. Councilman Kuntz asked if the zoning remains M-H, would there be any means of stopping the development progress. Director Hamilton stated that if the designation was for a mobile home subdivision, the individual lots would be platted; designation is for a mobile home park, a development plan would be approved by the Planning Commission. City Administrator Napier pointed out that an M-H designation would create multiple access points; there would be more control of the access points with a commercial designation. Councilman Carsrud asked for information regarding beautification requirements with each designation type. City Administrator Napier stated that there are more beautification requirements for a commercial designation than for a mobile home designation. Mayor Carter-King reminded the public that this is the first of three readings, there will still be more opportunities for changes. Nancy Hagen expressed concern over the fact that the property in question is not currently maintained more than once per year, once the property is sold, will the property be maintained. After further discussion, Mayor Carter-King closed the public hearing.

ORDINANCE 15-15

AN ORDINANCE TO AMEND THE DISTRICT ZONING MAP
OF THE CITY OF GILLETTE, WYOMING, LEGALLY DESCRIBED AS A PORTION OF
TRACT 2C, ENERGY PARK THIRD ADDITION, FROM M-H, MOBILE HOME
DISTRICT, TO C-1, GENERAL COMMERCIAL DISTRICT,
SUBJECT TO ALL PLANNING REQUIREMENTS

It was moved by Councilman Carsrud and seconded by Councilman Jerred to approve the foregoing Ordinance on first reading. Mayor Carter-King asked for discussion. Councilman Kuntz stated that Councilman McGrath wanted the public to be informed that, if he were present, he would oppose the ordinance change on first reading. Councilman Barks commented that he would be in favor of the ordinance with the understanding that Staff will create the notes on the plat that would restrict the use of the property. City Administrator Napier stated that Staff will collaborate and prepare the appropriate instrument, whatever it may be, to include the noted restrictions. After the discussion, roll was called on the motion with the following results. Council Members voting aye: Barks, Carsrud, Jerred, Kuntz, Rothleutner, and Mayor Carter-King. The Presiding Officer declared the motion carried.

Mayor Carter-King opened into a public hearing to consider amendments to the Gillette City Budget for FY2014-2015. Mayor Carter-King asked for discussion. There was none. Mayor Carter-King closed the public hearing.

RESOLUTION 2524

A RESOLUTION AMENDING THE GILLETTE CITY BUDGET FOR THE 2014-2015 FISCAL YEAR PURSUANT TO W.S. 16-4-113.

It was moved by Councilman Jerred and seconded by Councilman Rothleutner to approve the foregoing Resolution to authorize the amendments to the Gillette City Budget for the 2014-2015 fiscal year pursuant to W.S. 16-4-113. Mayor Carter-King asked for discussion. There was none. Roll was called on the motion with the following results. Council Members voting aye: Carsrud, Jerred, Kuntz, Rothleutner, Barks, and Mayor Carter-King. The Presiding Officer declared the motion carried.

Mayor Carter-King opened into a public hearing to consider the Gillette City Budget for FY2015-2016. Mayor Carter-King asked for discussion. Council thanked staff for their efforts in creating the budget. After the discussion, Mayor Carter-King closed the public hearing.

ORDINANCE 3861

AN ORDINANCE PROVIDING FOR THE ANNUAL APPROPRIATION OF MONEY FOR THE MAINTENANCE OF THE CITY OF GILLETTE, WYOMING, FOR FY2015-2016

It was moved by Councilman Kuntz and seconded by Councilman Rothleutner to approve the foregoing Ordinance on third and final reading. Mayor Carter-King asked for discussion. Councilman Barks asked for the dollar amount of the budget. City Administrator Napier stated the budget is \$173,346,202. Councilman Jerred asked for the dollar amount dedicated to the Madison Project. City Administrator Napier stated that approximately 44 million dollars will be dedicated to the Madison Project. Councilman Kuntz expressed his gratitude to staff for creating a conservative budget. After the discussion, roll was called on the motion with the following results. Council Members voting aye: Jerred, Kuntz, Rothleutner voted aye, however, abstained from budget matters pertaining to personnel, Barks, Carsrud, and Mayor Carter-King. The Presiding Officer declared the motion carried.
