City Attorney Anderson stated the restrictive covenant would remain with the recorded plat, binding the lot forever. Councilman McGrath stated that he was absent for the first reading of the Ordinance, however, in speaking with residents in the area, most offered resistance to the changes proposed in the Ordinance. Mayor Carter-King stated that many residents addressed the Council with their concerns at the first reading of the Ordinance. The application deadline would be August 7, after which applicants would be scheduled to meet with the Council to discuss, in detail, how they plan to utilize the retail liquor license if they are chosen to receive that asset. The Resolution outlines the deadlines and application process for the possible issuance of the retail liquor license. Councilman Jerred stated that applicants have 30 days to prepare for the process. Councilman Barks stated that Council may or may not award the liquor license based on the applications. It was moved by Councilman Rothleutner and seconded by Councilman Carsrud to amend the foregoing Resolution by changing the verbiage in the title from "Smoke Free" to "Tobacco Free". Councilman Barks asked legal counsel if amending the title would achieve the results of regulating a completely tobacco free facility. City Attorney Anderson stated that amending the title of the Resolution would not affect the verbiage in the Resolution, in that it would still restrict the use of cigarette, pipe, cigar, and electronic

cigarette (e-cigarette) smoking. Mayor Carter-King asked if this restriction would also include chewing tobacco. City Attorney Anderson replied that changing the motion would only modify the title of the Resolution and would not change the verbiage within the Resolution. City Administrator Napier suggested that the verbiage could include "all tobacco products" in the list of restricted items. Councilman Jerred asked how the restrictions would be enforced. Councilman Barks commented that from past experience with establishing policies similar to this, most people tend to police themselves and obey the rules, especially with the acceptance of smoke free zones in today's society. Councilman Jerred commented that chewing tobacco was not as obvious as smoking a cigarette, and he felt it would be more difficult to police. Councilman Kuntz stated that because this is a Resolution, not an Ordinance, the policy would not be enforced by the issuance of citations, it would be controlled by signage. Councilman Rothleutner retracted the amendment to the Resolution and restated the motion as "A Resolution Declaring the Bleachers, Spectator Seating and Playing Fields at Dalbey Park and the Energy Capital Sports Complex "Tobacco Free", and adding the verbiage of "tobacco products" to the list of restrictions. Roll was called on the amendment with the following results. Council members voting aye: Jerred, Kuntz, McGrath, Rothleutner, Barks, Carsrud, and Mayor Carter-King. It was moved by Councilman Rothleutner and seconded by Councilman Jerred to approve the amended Resolution declaring the bleachers, spectator seating and playing fields at Dalbey Park and the Energy Capital Sports Complex tobacco free. Mayor Carter-King asked for discussion. There was none. Roll was called on the motion with the following results. Council members voting aye: Carsrud, Jerred, Kuntz, McGrath, Rothleutner, Barks, and Mayor Carter-King. The Presiding Office declared the motion carried.

#### Resolution No. 2528

A RESOLUTION AUTHORIZING THE FILING OF AN APPLICATION FOR FUNDING UNDER THE WYOMING TRANSPORTATION ALTERNATIVES PROGRAM, (TAP) PROGRAM, ADMINISTERED BY THE WYOMING DEPARTMENT OF TRANSPORTATION.

It was moved by Councilman Rothleutner and seconded by Councilman Carsrud to approve the foregoing Resolution authorizing the filing of an application for funding under the Wyoming Transportation Alternatives Program, (TAP) Program, administered by the Wyoming Department of Transportation. Mayor Carter-King asked City Administrator Napier to explain the Resolution. City Administrator Napier explained that the Resolution would allow the City to apply for grant funding to construct a pathway that connects the Dalbey Park Fishing Lake area to the Energy Capital Sports Complex, primarily along the Sinclair right-of-way. It is anticipated that the program will be approximately a \$330,000 project, funded on an 80% basis, the match of which would be provided through the 1%  $\,$ Project in the Pathways program. Councilman Barks asked if the project will continue if the grant funding is unsuccessful. City Administrator Napier stated that if the grant funding is unsuccessful, the project will be brought before Council to determine an alternate means of funding. After the discussion, roll was called on the motion with the following results. Council Members voting aye: Kuntz, McGrath, Rothleutner, Barks, Carsrud, Jerred, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman Rothleutner and seconded by Councilman Barks to table the consideration for the approval of a real estate listing agreement and authorization to publish a notice of land sale and call for sealed bids to sell the house and lot at 2000 Autumn Court within the City of Gillette. Roll was called on the

motion with the following results. Council Members voting aye: Rothleutner, Barks, Carsrud, Jerred, Kuntz, McGrath, and Mayor Carter-King. The Presiding Officer declared the motion to table the item carried.

It was moved by Councilman Rothleutner and seconded by Councilman Carsrud to approve a bid award for the base bid and additive alternate #1 for the AVA building roof replacement to Hladky Construction, Inc., in the total amount of \$254,619. Mayor Carter-King asked for discussion. Councilman Rothleutner explained that the discrepancy between the verbiage on the agenda and the motion was due to the fact that the approval will not include the additive alternate #2, therefore, the total dollar amount was reduced. After the discussion, roll was called on the motion with the following results. Council members voting aye: Barks, Carsrud, Jerred, Kuntz, McGrath, Rothleutner, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman Carsrud and seconded by Councilman Rothleutner to approve a bid award for the Gillette Madison Pipeline Phase III Rehabilitation Project to WBI Energy Corrosion Services in the Amount of \$547,490. Mayor Carter-King asked for discussion. There was none. Roll was called on the motion with the following results. Council members voting aye: Carsrud, Jerred, Kuntz, McGrath, Rothleutner, Barks, and Mayor Carter-King. The Presiding Officer declared the motion carried.

## <u>Appointments</u>

It was moved by Council President Rothleutner and seconded by Councilman Jerred to appoint Billy Montgomery to the Board of Adjustment; William Yount to the Investment Advisory Committee; and Bill Ellingson and Cindy Reardon to the Planning Commission. Mayor Carter-King asked for discussion. There was none. Roll was called on the motion with the following results. Council Members voting aye: Jerred, Kuntz, McGrath, Rothleutner, Barks, Carsrud, and Mayor Carter-King. The Presiding Officer declared the motion carried. Mayor Carter-King expressed thanks to the appointees for volunteering to serve the community.

# Administrator's Report

Mayor Carter-King asked for an Administrator's report. City Administrator Napier reported there was no report.

#### Special Orders of the Day

Mayor Carter-King opened into a public hearing for a zoning map amendment for Lots 5 and 6, Block 5, Moon Shadow No. 2 First Filing, from C-O, Office and Institution District, to C-P, Planned Neighborhood Business District. Mayor Carter-King asked for discussion. Hearing none, Mayor Carter-King closed the public hearing.
