AN ORDINANCE TO AMEND THE DISTRICT ZONING MAP
OF THE CITY OF GILLETTE, WYOMING, FOR A PORTION OF TRACT D, ASH
MEADOWS SUBDIVISION, PHASE II, FROM M-H, MOBILE HOME DISTRICT,
TO I-1, LIGHT INDUSTRIAL DISTRICT,
SUBJECT TO ALL PLANNING REQUIREMENTS

THE PROPERTY IS MORE PARTICULARLY DESCRIBED AS:

Beginning at the SW corer of Tract "D" representing the east right of way of Ash Meadows Drive, and the North Right of way of Nutwood Lane.

Thence S 89° 26'49" E along the north ROW of Nutwood Lane a distance of 137.45 feet to a point;

Thence S 00° 00' 00" W a distance of 160.01 feet to a point;

Thence S 89° 26'49" E a distance of 861.66 feet to a point on the east boundary of said tract "D":

Thence N 00° 17' 56" W along the east boundary of Tract "D" a distance of 733.14 feet to the NE corner of said tract;

Thence N 86° 30'31" W along the north boundary of Tract "D", being the south ROW of Northern Drive, a distance of 793.53 feet, to a point on the proposed east boundary of the future Ash Meadows drive;

Thence S 03° 29'26" W along the future east ROW of Ash Meadows Drive, a distance of 8.50 feet to a point:

Thence continuing along the future ROW of Ash Meadows drive, through a curve to the right having a radius of 330.00', Chord Bearing: S 12°33'58" W, Chord length 104.11 feet, a distance of 104.54 feet to a point;

Thence continuing along the future ROW of Ash Meadows drive, S 21° 38'30" W, a distance of 406.44 feet to a point;

Thence continuing along the future ROW of Ash Meadows drive, through a curve to the left having a radius of 270.00', Chord Bearing: S 13°39'33" W, Chord length 127.52 feet, a distance of 128.74 feet to the point of beginning; Containing 15.40 acres more or less

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GILLETTE, WYOMING, THAT:

Section 1. The Zoning of the parcel legally described above and shown on the attached Exhibit A Map from M-H, Mobile Home District, to I-1, Light Industrial District.

Section 2. A Subdivision Plat covering the land area to be rezoned and conforming to the rezoning configuration shall be submitted, approved, and recorded prior to the rezoning taking effect.
