Roll was called on the motion with the following results. Council Members voting aye: Barks, Carsrud, Jerred, Kuntz, McGrath, and Mayor Carter-King. The Presiding Officer declared the motion carried.

ORDINANCE 15-26

AN ORDINANCE TO AMEND SECTION 5-IV-1(a) AND SECTION 5-IV-3(a) OF THE GILLETTE CITY CODE CONCERNING PLAN REVIEW AND PERMIT FEES

It was moved by Councilman Carsrud and seconded by Councilman McGrath to approve the foregoing Ordinance on second reading. Mayor Carter-King asked for discussion. There was none. Roll was called on the motion with the following results. Council Members voting aye: Carsrud, Jerred, Kuntz, McGrath, Barks, and Mayor Carter-King. The Presiding Officer declared the motion carried.

ORDINANCE 15-27

AN ORDINANCE TO ENACT STANDARDS FOR RESIDENTIAL FIRE SUPPRESSION SYSTEM LICENSES, BY AMENDING SECTION 5-III-5 AND SECTION 5-III-7 OF THE GILLETTE CITY CODE, ENACTING ARTICLE III (D) RESIDENTIAL FIRE

It was moved by Councilman Jerred and seconded by Councilman Barks to approve the foregoing Ordinance on second reading. Mayor Carter-King asked for discussion. There was none. Roll was called on the motion with the following results. Council Members voting aye: Jerred, Kuntz, McGrath, Barks, Carsrud, and Mayor Carter-King. The Presiding Officer declared the motion carried.

New Business

It was moved by Councilman Carsrud and seconded by Councilman Barks to approve a professional services agreement for design and bidding services associated with the concrete apron repair Z1-R4 (Southern Drive Tank) and driveway repair Z1-R5 (Hidden Valley Tank) project with Morrison-Maierle, Inc., in the amount of \$29,953 (1% Project). Mayor Carter-King asked for an explanation regarding the request. City Administrator Napier explained the repairs of the two tanks. It is anticipated, from a budgetary standpoint, that this could amount to as much as \$425,000 in terms of the full scope of the project. Councilman Jerred asked the age of the concrete. Mr. Napier reported that he did not have this information available, however, staff would gather the information for the upcoming General Information Packet. After the discussion, roll was called on the motion with the following results. Council Members voting aye: Kuntz, McGrath, Barks, Carsrud, Jerred, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman Jerred and seconded by Councilman McGrath to approve a bid award for the Gillette Madison Pipeline Project, Contract #2a, to Layne Christensen Company, in the amount \$14,027,028. Mayor Carter-King asked for an explanation regarding the request. City Administrator Napier explained that this is an extensive well project. There will be three (3) wells drilled as part of the scope of this project. Three (3) bid proposals were received with Layne Christensen Company appearing to be the low bidder with respect to the alternate and base bid they for The engineer's estimate the project approximately, \$14,800,000. Jason Lamb, Boart Longyear Drilling Services, asked the Council to practice their right to negotiate terms and conditions and consider the amount of money that would be saved by looking at the base bids. According to Mr. Lamb, it would be a 1.5 million dollar savings on the base bids and a \$100,000 savings on the alternative bids. In closing, he asked, if the other drilling company is awarded the bid, to keep Boart Longyear Drilling Services in mind for future projects. Councilman Barks commented on the timing urgency and Councilman Jerred asked if Mr. Lamb's company has drilled holes in this area. Mr. Lamb stated that he has not, but would like the opportunity to show the different methods and tools being used. Nathan Anderson, District Manager, Layne Christensen Company's Denver office, reported on the successful drilling projects regarding the first two Madison test wells. He pointed out verbiage in the bid spec's regarding the award of a bid and the consideration of both the base bid and additive alternatives in making the determination. He then pointed out issues that were encountered in drilling the first two wells and stated that the issues were covered under the added alternatives. He added that Layne Christensen Company responded to the bid with no clarifications and no qualifiers. His company understands the terms and the risks. Councilman Jerred asked if Mr. Anderson is confident that the three wells will be drilled in the allotted amount of time. Mr. Anderson confirmed he is confident that the three wells will be drilled in the allotted amount of time; they have the same tools and the same tool pusher. Councilman

Barks asked if more wells will need to be drilled in the future. Utilities Project Manager Jensen confirmed there will be, when the demand is there for future wells. Seven wells are anticipated in the future and the location for the next phase of the well field is being reviewed. The timeline is approximately, five to ten years, depending on population growth. Mr. Lamb stated that he does not agree with Mr. Anderson's comments regarding the successful drilling project of the Madison wells. When liquidated damages are entertained and paid out, he doesn't feel as if this was a successful project. Councilman McGrath commented that he supports awarding the bid to Layne Christensen Company as the State is also in agreement with awarding the bid to this company. After the discussion, roll was called on the motion with the following results. Council Members voting aye: McGrath, Barks, Carsrud, Jerred, Kuntz, and Mayor Carter-King. The Presiding Officer declared the motion carried.

RESOLUTION 2542

A RESOLUTION CONCERNING THE FINANCING OF THE CONSTRUCTION AND EQUIPMENT OF A DORMITORY ON THE NORTHERN WYOMING COMMUNITY COLLEGE DISTRICT/GILLETTE COLLEGE CAMPUS, TO BE LEASED BY THE CITY OF GILLETTE, WYOMING, FROM THE GILLETTE COLLEGE STUDENT HOUSING PHASE II STATUTORY TRUST; AUTHORIZING AND APPROVING THE SITE LEASE, THE LEASE PURCHASE AGREEMENT, A PURCHASER AGREEMENT, WRITTEN PROCEDURES RELATING TO TAX-EXEMPT OBLIGATIONS OF THE CITY, AND RELATED DOCUMENTS AND TRANSACTIONS; RATIFYING ACTION PREVIOUSLY TAKEN; PROVIDING OTHER MATTERS RELATING THERETO; AND PROVIDING THE EFFECTIVE DATE THEREOF.

It was moved by Councilman Jerred and seconded by Councilman Carsrud to approve the foregoing Resolution concerning the financing of the construction and equipment of a dormitory on the Northern Wyoming Community College District/Gillette College Campus, to be leased by the City of Gillette, Wyoming, from the Gillette College Student Housing Phase II Statutory Trust. Mayor Carter-King asked for an explanation of the request. City Administrator Napier explained the resolution will allow staff to move forward with the closing that will create the statutory trust that allows for the issuance of Certificates of Participation. He informed Council that the Resolution distributed at the Pre-Meeting is the one to be considered for approval versus the Resolution that was in the Council packet. It is his understanding that the only correction is to the dollar amount. City Attorney Anderson explained that the final price for the project was determined today. He then reported on other agreements that will be approved in the Resolution, as well. Councilman Jerred asked if local lending institutions showed any interest. Mr. Napier reported that no local lending institutions showed interest. Councilman Kuntz asked for the dollar amount. City Attorney Anderson reported \$11,650,000 is the amount of the certificate; the City is also spending \$1,000,000 that was budgeted for this project. Mayor Carter-King asked if there is a completion date. Development Services Director Hamilton reported the goal for the project is to be open in the fall of 2016. After the discussion, roll was called on the motion with the following results. Council Members voting aye: Barks, Carsrud, Jerred, Kuntz, McGrath, and Mayor Carter-King. The Presiding Officer declared the motion carried.

RESOLUTION 2543

A RESOLUTION APPROVING AND AUTHORIZING THE FINAL PLAT FOR THE RESUBDIVISION OF TRACT B1, RC RANCH PHASE 1, TO THE CITY OF GILLETTE, WYOMING, SUBJECT TO ALL PLANNING REQUIREMENTS

It was moved by Councilman Jerred and seconded by Councilman Barks to approve the foregoing Resolution approving and authorizing the final plat for the resubdivision of Tract B1, RC Ranch, Phase I, to the City of Gillette, Wyoming, subject to all Planning requirements. Mayor Carter-King asked for discussion. Councilman Jerred noted that this is the portion that will serve the new fire station. Roll was called on the motion with the following results. Council Members voting aye: Carsrud, Jerred, Kuntz, McGrath, Barks, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman Carsrud and seconded by Councilman McGrath to authorize the Chophouse to apply for the available retail liquor license. Mayor Carter-King stated that four very good applicants were considered and this was a very hard decision. Brent Eischeid, Chophouse, thanked the Council for their service and the opportunity to apply for the retail liquor license. He reported that he is willing to tie stipulations to the issuance of the retail liquor license and explained their upcoming remodeling efforts. Mayor Carter-King inquired about the stipulations as part of the consideration for the liquor license. City Attorney Anderson stated that notes from the presentation and power point would be used in the verbiage regarding stipulations for the issuance of the liquor license. Discussions with the applicant regarding these stipulations have taken place and the applicant indicated he would agree to them. Mayor Carter-King reminded everyone that this consideration is not to award the liquor license, but to begin the application process only. There will be a public hearing, at which time the issuance of the liquor license will be considered. Councilman Kuntz reported the many calls and questions he has received. Councilman Jerred stated that consideration needs to be taken on what will generate new income for the City. Debra Heron, Walmart, thanked the Council for their public service and time regarding this matter. After the discussion, roll was called on the motion with the following results. Council Members voting aye: Kuntz, McGrath, Carsrud, and Mayor Carter-King (who explained that she did not want a tie and, therefore, would vote with the majority). Voting nay: Jerred and Barks. The Presiding Officer declared the motion carried.

RESOLUTION 2544

A RESOLUTION TO PROVIDE WATER TO THE BENNOR IMPROVEMENT AND SERVICE DISTRICT ON AN EMERGENCY BASIS.

It was moved by Councilman Carsrud and seconded by Councilman McGrath to approve the foregoing Resolution to provide water to the Bennor Improvement and Service District on an emergency basis. Utilities Director Glover explained that the Bennor Improvement and Service District is under an EPA mandate to find an alternative water source, immediately. This will put in place the ability to include this water district, on an emergency basis, and that they be charged the anticipated Madison water rate for regional customers. Councilman Jerred noted that the Bennor Improvement and Service District has agreed to the voluntary restricted watering schedule. Lynn Gray thanked the Council for their consideration in this matter. After the discussion, roll was called on the motion with the following results. Council Members voting aye: Kuntz, McGrath, Barks, Carsrud, Jerred, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman McGrath and seconded by Councilman Barks to accept public improvements for the School Zone Crossings Phase I Project, installed by Powder River Construction, Inc., in the amount of \$236,117.79 (1% Project). Councilmen McGrath and Jerred

commented on the visibility of the beacons. City Administrator Napier added that this project is also a partnership with WYDOT in an 80/20 format and reported a savings of over \$14,000. After the explanation, roll was called on the motion with the following results. Council Members voting aye: McGrath, Barks, Carsrud, Jerred, Kuntz, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman Carsrud and seconded by Councilman Barks to accept public improvements for the Raymond Street Improvements Project installed by Melgaard Construction Company, Inc., in the amount of \$301,902.75 (1% Project). Mayor Carter-King asked for an explanation regarding the request. City Administrator Napier explained the improvements and timeliness of the project. After the explanation, roll was called on the motion with the following results Council Members voting aye: Barks, Carsrud, Jerred, Kuntz, McGrath, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman Jerred and seconded by Councilman Barks to approve a professional services agreement for design and bidding services associated with the Pavement Management System 2016 Schedule A Project, with Morrison-Maierle, Inc., in the amount of \$110,214 (1% Project). Mayor Carter-King asked for an explanation regarding the request. City Administrator Napier explained that this is a pavement management project that will include several areas near Brooks Avenue. Mr. Napier expressed concern regarding the impact it could have on the community where Brooks Avenue crosses the railroad; there may be a closing of this crossing for a time. After the explanation, roll was called on the motion with the following results. Council Members voting aye: Carsrud, Jerred, Kuntz, McGrath, Barks, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman Barks and seconded by Councilman Carsrud to accept public improvements for the Gurley Overpass Pier 5 and Abutment 2 Structural Repair Project, completed by S&S Builders, LLC, in the amount of \$159,611.96 (1% Project). Mayor Carter-King asked for an explanation regarding the request. City Administrator Napier explained the project. There were no delays and the project netted a savings of over \$8,000. After the explanation, roll was called on the motion with the following results. Council Members voting aye: Jerred, Kuntz, McGrath, Barks, Carsrud, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman Carsrud and seconded by Councilman McGrath to approve a professional services agreement for evaluating, modeling, and updating the City of Gillette's Transportation Master Plan, with DOWL, in the amount of \$131,819 (1% Project). Mayor Carter-King asked for an explanation regarding the request. City Administrator Napier explained the Transportation Plan and stated that it is time to update the Plan in order to be relevant into the future. After the explanation, roll was called on the motion with the following results. Council Members voting aye: Kuntz, McGrath, Barks, Carsrud, Jerred, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman Jerred and seconded by Councilman McGrath to approve a professional services agreement for design associated with the Boxelder Road enhancements from Emerson Avenue to Hwy 59, with PCA Engineering, Inc., in the amount of \$125,192 (1% Project). Mayor Carter-King asked for an explanation regarding the request. City Administrator Napier explained that this aspect of the project will provide for the design to straighten out the "S" curve on Boxelder Road from Emerson Avenue, east, to Hwy 59.

Councilman Barks asked for a timeline of the project. Development Services Director Hamilton explained that the budget only provides for the design at this point. The budget will also provide for an interim traffic light located at Kmart's north approach. The actual construction has not been budgeted for. After the discussion, roll was called on the motion with the following results. Council Members voting aye: McGrath, Barks, Carsrud, Jerred, Kuntz, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Councilman McGrath and seconded by Councilman Carsrud to approve a professional services agreement for design and bidding services associated with the Alley 2016 Pavement Management System, with Bruce Engineering, Inc., in the amount of \$35,983 (1% Project). Mayor Carter-King asked for an explanation regarding the request. City Administrator Napier explained the conditions of the alleys and that the downtown area will be the benefactor of the alley improvement project. Steve Bruce thanked the Council for their consideration. Councilman McGrath asked that the citizens in the area be notified regarding the project. After the discussion, roll was called on the motion with the following results. Council Members voting aye: Barks, Carsrud, Jerred, Kuntz, McGrath, and Mayor Carter-King. The Presiding Officer declared the motion carried.

Appointments

It was moved by Councilman McGrath and seconded by Councilman Barks to appoint Councilman Tim Carsrud as Council President for the remainder of 2015 and for 2016. Mayor Carter-King asked for discussion. There was none. Roll was called on the motion with the following results. Council Members voting aye: Jerred, Kuntz, McGrath, Barks, and Mayor Carter-King. Councilman Carsrud abstained. The Presiding Officer declared the motion carried.

It was moved by Council President Carsrud and seconded by Councilman Barks to appoint Matt Stroop to the Parks & Beautification Board. Mayor Carter-King asked for discussion. There was none. Roll was called on the motion with the following results. Council Members voting aye: Jerred, Kuntz, McGrath, Barks, Carsrud, and Mayor Carter-King. The Presiding Officer declared the motion carried.

It was moved by Council President Carsrud and seconded by Councilman Barks to table the appointment of a City Board Member to the Boys and Girls Club Board. Roll was called on the motion with the following results. Council Members voting aye: Kuntz, McGrath, Barks, Carsrud, Jerred, and Mayor Carter-King. The Presiding Officer declared the motion carried and the appointment tabled.

Administrator's Report

Mayor Carter-King asked for an Administrator's report. City Administrator Napier reported there was no report.

Special Orders of the Day

Mayor Carter-King opened a public hearing to consider amendments to the Gillette City Budget for FY2015/2016. City Administrator Napier explained the items with respect to the amendment request. He assured Council that more dollars are not being requested; the primary function of the amendment is to carry dollars forward from projects that were budgeted in the previous fiscal year in order to book those projects in the new fiscal year. He added that a large

part of the amendment has to do with the Madison Pipeline. After the explanation, Mayor Carter-King closed the public hearing.

RESOLUTION 2545

A RESOLUTION AMENDING THE GILLETTE CITY BUDGET FOR THE 2015-16 FISCAL YEAR PURSUANT TO W.S. 16-4-113

It was moved by Councilman Jerred and seconded by Councilman Carsrud to approve the foregoing Resolution amending the Gillette City Budget for FY2015/2016. Mayor Carter-King asked for discussion. There was none. Roll was called on the motion with the following results. Council Members voting aye: McGrath, Barks, Carsrud, Jerred, Kuntz, and Mayor Carter-King. The Presiding Officer declared the motion carried.

Mayor Carter-King opened into a public hearing for a zoning map amendment for a portion of Tract B1, RC Ranch Phase I, from A, Agricultural District, to C-1, General Commercial District. City Administrator Napier explained the amendment request is to change the zoning from agricultural to C-1, general commercial. As a side note, a portion of the land in question will be dedicated to the development of a new road known as Wenger Drive to primarily access the new fire station.
