AN ORDINANCE PROVIDING FOR THE VACATION
OF A 50 FOOT WIDE GENERAL UTILITY EASEMENT LOCATED ON TRACTS
P AND Q, MOON MEADOW ESTATES NO. 3, A RE-SUBDIVISION OF TRACT
4, MOON MEADOW ESTATES, AND TRACTS K AND J, MOON MEADOW
ESTATES NO.2, AS SHOWN ON THE EXHIBIT "A" MAP, IN THE CITY OF
GILLETTE, WYOMING, SUBJECT TO ALL PLANNING REQUIREMENTS

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GILLETTE, WYOMING:
