ORDINANCE NO.

AN ORDINANCE AMENDING GILLETTE CITY CODE SECTIONS 17-6.A.1, 17-6.B.1, 17-6.C.1, 17-6.D.1, 17-6.E.1, 17-6.F.5(a), REPEALING SECTION 17-6.G, RENUMBERING SECTIONS 17-6.H THROUGH K -6.G THROUGH J, AMENDING 17-6.G.3 AND ENACTING 17-6. K, TO REVISE RATES FOR ELECTRICAL SERVICE SUPPLIED BY THE CITY OF GILLETTE.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GILLETTE, WYOMING:

SECTION ONE. Section 17-6.A.1. of the Gillette City Code is amended to read as follows:

1. The rates to be charged for domestic purposes shall consist of a fixed monthly Customer Charge and an Energy Charge based upon consumption.

SECTION TWO. Section 17-6.B.1. of the Gillette City Code is amended to read as follows:

1. The rates for domestic purposes in approved All-Electric private dwellings shall consist of a fixed monthly Customer Charge and an Energy Charge based upon consumption.

SECTION THREE. Section 17-6.C.1. of the Gillette City Code is amended to read as follows:

1. The rates to be charged for commercial and miscellaneous purposes shall consist of a fixed monthly Customer Charge and an Energy Charge based upon consumption.

SECTION FOUR. Section 17-6.D.1. of the Gillette City Code is amended to read as follows:

1. The Rates to be charged for the Optional Small Commercial and Miscellaneous Service Rate shall consist of a fixed monthly Customer Charge and an Energy Charge based upon consumption.

SECTION FIVE. Section 17-6.E.1. of the Gillette City Code is amended to read as follows:

1. The rates to be charged for those customers with demand meters shall consist of a fixed monthly Customer Charge, an Energy Charge based upon consumption and a monthly Demand charge. The Demand charge is determined by multiplying the Demand Rate by the peak demand in a billing cycle. The peak demand is shown or computed from the readings of the City's demand meter which shows the highest average peak over any given 15 minute period of customer's greatest use during the billing period.

SECTION SIX. Section 17-6.F.5(a) of the Gillette City Code is amended to read as follows:

(a) Each customer shall pay \$75.25 per month as a customer charge, and

SECTION SEVEN. Section 17-6.G of the Gillette City Code is repealed. Sections 17-6.H through K are renumbered 17-6.G through J.

SECTION EIGHT. Section 17-6.G.3 of the Gillette City Code is amended to read as follows:

(3) Each 100 kWh block billed under this rate shall be bill at a rate of \$.0020 per kilowatt hour. (Ord. 3494, 6-18-2007; Ord. 3557, 5-19-08; Ord. 3754, 4-16-2012)

SECTION NINE. Section 17-6.K. of the Gillette City Code is enacted to read as follows:
