AN ORDINANCE PROVIDING FOR THE REPEAL OF ORDINANCE NO. 3711 WHICH APPROVED AND AUTHORIZED THE CONDOMINIUM PLAT FOR BIG TOY STORAGE, BUILDING B, LOCATED ON A PORTION OF LOT 2, MOON MEADOW ESTATES SUBDIVISION #5 TO THE CITY OF GILLETTE, WYOMING, SUBJECT TO ALL PLANNING REQUIREMENTS

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF GILLETTE, WYOMING, THAT:
