RESOLUTION 2557

A RESOLUTION APPROVING AND AUTHORIZING THE FINAL PLAT FOR RESUBDIVISION OF LOT 1 VISTA GRANDE SUBDIVISION, TO THE CITY OF GILLETTE, WYOMING, SUBJECT TO ALL PLANNING REQUIREMENTS

It was moved by Councilman Jerred and seconded by Councilman Barks to approve the foregoing Resolution approving and authorizing the final plat for the resubdivision of Lot 1 Vista Grande Subdivision, to the City of Gillette, Wyoming, subject to all Planning requirements. Mayor Carter-King asked for discussion. There was none. Council was asked to cast their vote. The vote was recorded as follows: Jerred, Barks, Montgomery, McGrath, Kuntz, and Mayor Carter-King voting aye. The motion carried.

It was moved by Councilman Barks and seconded by Councilman McGrath to approve a bid award as adjusted per the revised scope of work, for the installation of a temporary traffic signal at the Boxelder Road/K-Mart approach to Windcreek Services, Inc., in the amount of \$98,895 (1% project). Mayor Carter-King asked for an explanation regarding the request. City Administrator Napier explained that this request is for the temporary traffic signal installation, not the permanent installation of a traffic signal, on Boxelder Road at the K-Mart approach that would likely occur for the re-construction of Boxelder Road at some point in the future. This would be a pole and span wire installation. The engineer's estimate is significantly lower at \$73,728. Council inquired if they were to vote against this request due to the engineer's estimate being lower than the requested amount, what the process would be. Mr. Napier replied that the process would be to continue with the project, likely diverting much of the work internally. After further discussion, Council was asked to cast their vote. The vote was recorded as follows: Jerred, Barks, Montgomery, McGrath, Kuntz, and Mayor Carter-King voting nay. The motion failed.

It was moved by Councilman Barks and seconded by Councilman McGrath to approve a professional services agreement for construction management associated with the Boxelder Road utilities from Overdale Drive to Highway 50, with DOWL Engineering, in the amount of \$60,095 (1% project). Mayor Carter-King asked for discussion. City Administrator Napier explained that this is effectively, the last connection on Boxelder Road from Overdale Drive to the Cam-Plex. The City's responsibility is the utilities under Boxelder Road, once constructed. Staff is recommending for the approval of the request. Council inquired if they were to vote against this request what would be the process. City Administrator Napier explained that staff would recommend that the oversight continue as to not hamper or slow down the project; or in a worst case scenario, prevent the project from proceeding. As explained during the previous discussions, if Council were to vote this request down, staff resources would be re-allocated to assist with the oversight where we have the capacity to do so, and effectively, reduce the scope to DOWL for services staff does not have the capacity to provide, at this point in time. That would likely mean, the value of the services needed from DOWL would fall beneath the Council's oversight for approval, and staff would enter into a smaller contract that would be signed at the staff level. If this request is not approved by the Council, it would not slow down the project, giving staff time to make appropriate arrangements made, from a re-allocation standpoint, internally and with DOWL. Council inquired of the savings if this request is not approved. Mr. Napier reported, minus the overtime that would incur to provide limited oversight services, there would be a savings of approximately, \$30,000. Mr. Napier added that this is a partnership with the Urban Systems program and it is a 90/10 split; the State is paying for the construction of the road and the City is responsible for the utilities. After the discussion, Council was asked to cast their vote. The vote was recorded as follows: Jerred, Barks, Montgomery, McGrath, Kuntz, and Mayor Carter-King voting nay. The motion failed.

It was moved by Councilman Barks and seconded by Councilman Kuntz to approve a professional services agreement for Phase I of the implementation of PAVER Software for overall management of the City's roadway system infrastructure, with PERTAN, Inc., in the amount of \$100,028 (1% project). Mayor Carter-King asked for an explanation regarding the request. City Administrator Napier explained that this is not a software that can be replicated internally. We have reached the extent with the current software and its abilities to provide efficiencies for mapping and planning future projects, such as pavement management. This software will create efficiencies for staff to insource from a design and management standpoint. Staff is recommending the approval for the purchase of the software. These dollars are within this year's budget figures and this will be the first phase; staff is expecting a smaller phase of implementation, for Council's consideration, later in the construction season to complete the implementation. After the explanation, Council was asked to cast their vote. The vote was recorded as follows: Jerred, Barks, Montgomery, McGrath, Kuntz, and Mayor Carter-King voting aye. The motion carried.

It was moved by Councilman Jerred and seconded by Councilman McGrath to authorize City staff to volunteer to work at the National High School Finals Rodeo (NHSFR) using up to four (4) hours of personal time and up to four (4) hours of employer paid time. Mayor Carter-King asked for an explanation regarding the request. City Administrator Napier explained that this has been done for a number of years in order to help the rodeo be a

success. There are approximately, 6 - 10 employees who have used the program in the past, and added, that there are those employees who volunteer their time without the compensation of employer paid time. Councilman McGrath suggested that Council lead by example and volunteer some time as well, and added even though Council is not reimbursed for their time. After the discussion, Council was asked to cast their vote. The vote was recorded as follows: Jerred, Barks, Montgomery, McGrath, Kuntz, and Mayor Carter-King voting aye. The motion carried.

Special Orders of the Day

Mayor Carter-King opened a public hearing for a zoning map amendment for property generally located at 1490 Harvest Moon Drive and legally described as a portion of Lot 2A Moon Meadow Estates No.5, a resubdivision of Lots 1 and 2 of Moon Meadow Estates No. 5, a resubdivision of Tract R of Moon Meadow Estates No. 3, from R-4, Multi-Family Residential District, to C-1, General Commercial District. Council inquired if this will complete what is needed in this area. Development Services Director Hamilton stated that this is the final step. It will be heard on March 8th on second reading and on March 15th for third and final reading in order to catch up with other projects relating to this item. After the discussion, Mayor Carter-King closed the public hearing.

It was moved by Councilman Barks and seconded by Councilman McGrath to approve the foregoing Ordinance on first reading. Mayor Carter-King asked for discussion. There was none. Council was asked to cast their vote. The vote was recorded as follows: Jerred, Barks, Montgomery, McGrath, Kuntz, and Mayor Carter-King. The motion carried.

Mayor Carter-King opened into a public hearing to consider amendments to the Gillette City Budget for FY2015-2016. City Administrator Napier explained the budget. The largest portion of the amendment is the financing to construct the college dormitories. He went on to explain the other items that included \$267,000 dedicated to the Gillette Golf & Country Club due to a commitment made approximately a year ago. Council added, because of the perception within the community, wanted to clarify that the City of Gillette does not own the Gillette Golf & Country Club. After the explanation, Mayor Carter-King closed the public hearing.

It was moved by Councilman Jerred and seconded by Councilman McGrath to approve the foregoing Resolution to approve amendments to the Gillette City Budget for FY2015-2016. It was moved by Councilman Barks and seconded by Councilman Kuntz to amend the

resolution by removing the Council of Community Services funding request and placing the request on the March 8th Special Meeting Agenda for further discussion. Mayor Carter-King asked for discussion on the amendment. There was none. Council was asked to cast their vote on the amendment. The vote was recorded as follows: Jerred, Barks, Montgomery, McGrath, Kuntz, and Mayor Carter-King voting aye. The motion carried and the resolution was amended and the Council of Community Services' funding request removed. Council was asked to cast their vote on the amended Resolution. The vote was recorded as follows: Jerred, Barks, Montgomery, McGrath, Kuntz, and Mayor Carter-King voting aye. The motion carried.
