A Work Session Meeting of the City Council was held on Tuesday, June 28, 2016.

Present were Councilmen Barks, Jerred, Kuntz, McGrath, Montgomery, and Mayor Carter-King; absent Councilman Carsrud; City Administrator Napier; Attorneys Anderson and Davidson; Directors Aguirre, Boger, Hloucal, Pitlick, and Wilde; Managers Palazzari and Davidsmeier; City Clerk Abelseth.

<u>Warm Up Items</u> Councilman McGrath notified the group that he would not be able to participate in the upcoming baseball tournament challenge with the County.

Mary Kelly and Charlene Busk, Campbell County Historical Society, presented pins commemorating the upcoming 125<sup>th</sup> Celebration of the establishment of Gillette.

Mayor Carter-King announced the recent ribbon cutting at Bennor Estates.

### National High School Finals Rodeo Presentation

Paul Foster, Cam-Plex's General Manager, requested a Letter of Support to host the NHSFR on a permanent basis beginning in the year 2020. Council was in agreement to provide a Letter of Support on the Cam-Plex's behalf.

### **Recycling Discussion**

City Administrator Napier provided three (3) options for Council to consider, regarding the recycling program. Several citizens, in favor of the recycling program, spoke to the Council. After the discussion, it was the consensus of the Council to move forward with Option 3, where the City is the collector within the corporate boundaries, and the County is the processor of the recycling program. It was also the consensus of the Council to end the Blue Bag Program in 60 davs.

### Adopt-A-Park Regulations Discussion

Discussion took place regarding the possible supplement of maintaining the City's "pocket parks". Director Wilde provided information on how the program could work.

### Discussion of a Proclamation Limiting Use of Water Preparation and Emergency Water Ordinance
