





WARRANTY DEED



Commencing at the northwest corner of aforementioned Lot 1; thence N89°46'09"E, 21.58 feet along and coincident with the north line of said Lot 1 to the easterly right of way of Butler Spaeth Road; thence S01°42'14"W, 487.08 feet along and coincident with said right of way to the beginning of a circular curve concave to the east; thence continuing along and coincident with said right of way through a curve having a central angle of 19°56'58", a radius of 550.00 feet, a curve length of 191.50 feet, a chord bearing of S08°16'15"E and a chord length of 190.53 feet to the south line of said Lot 1; thence S89°52'37"W, 34.34 feet to the west line of said Lot 1; thence N00°00'51"W, 675.41 feet along and coincident with the west line of said Lot 1 to the NW corner of said Lot 1 and the true point of beginning.

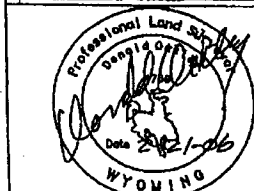
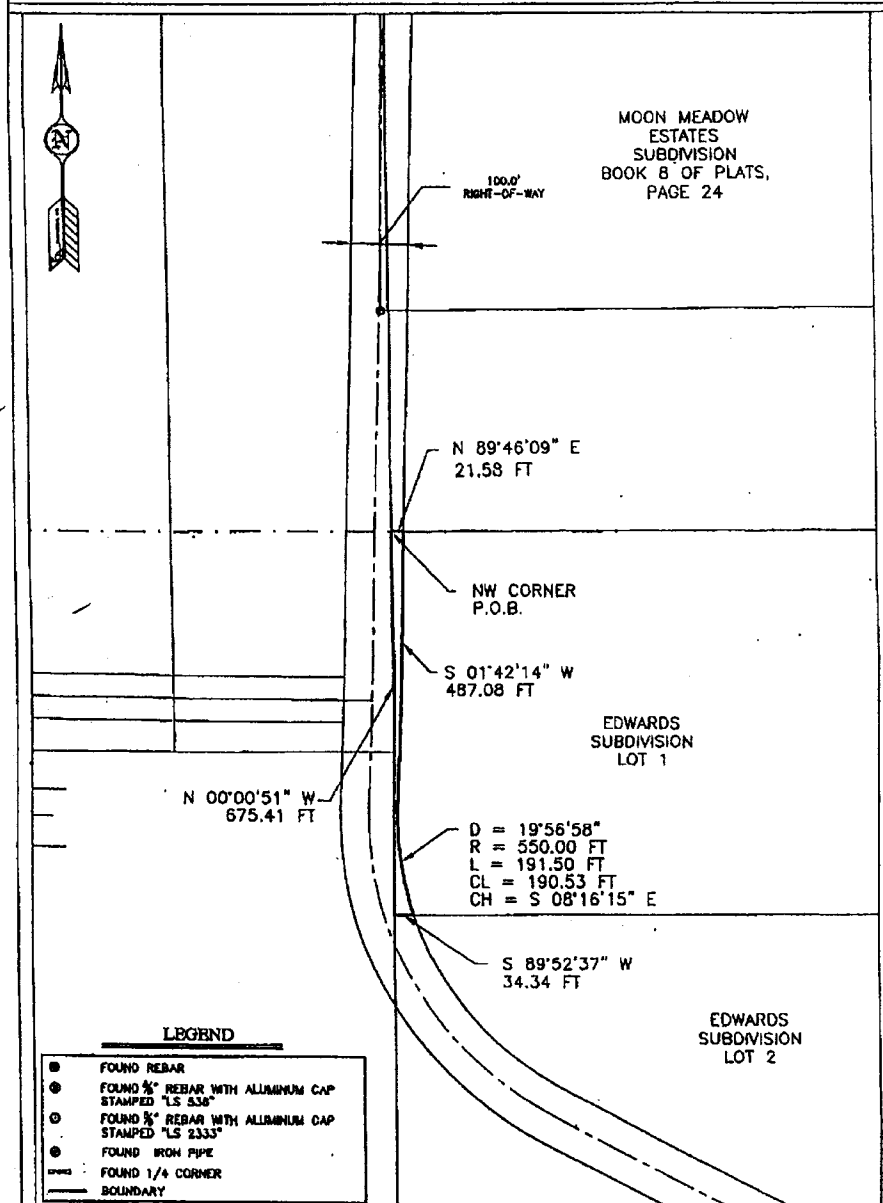

Commencing at the NE corner of SE¼NW¼ Section 2; thence S00°00'51"E, 391.39 feet along and coincident with the east line of said SE¼NW¼ and the true point of beginning; thence S00°00'51"E, 447.37 feet continuing along and coincident with said east line to the west right of way line of Butler Spaeth Road; thence along and coincident with said right of way through a curve concave to the east and having a central angle of 32°47'31", a radius of 650.00 feet, a curve length of 372.01 feet, a chord bearing of N14°41'32"W and a chord length of 366.96 feet; thence N01°42'14"E, 92.07 feet continuing along said right of way; thence N89°45'29"E, 90.22 feet to the east line of said SE¼NW¼ and the true point of beginning.
