We appreciate your cooperation and prompt action on this matter to ensure that each municipality is represented by a person who has been duly authorized by your governing body to take an active role in the business meeting.

If you find your official delegate is not able to attend the convention at the last moment, you may reappoint someone else. For this change to be accepted we do need the change in writing. You may send/fax it to the WAM office by Friday, May 12 or your voting delegate may bring the written change/authorization to convention and submit it to the WAM registration desk by Thursday, June 1 before 12:00n. After that time, changes will not be accepted.
