# A RESOLUTION DIRECTING STAFF TO MAIL ANNEXATION PETITIONS TO LANDOWNERS WITHIN CRESTVIEW, ANTELOPE VALLEY, ANTELOPE VALLEY BUSINESS PARK AND SURROUNDING AREA

Councilman Carsrud made a motion to approve the foregoing Resolution directing staff to mail annexation petitions to landowners within Crestview, Antelope Valley, Antelope Valley Business Park and surrounding area; seconded by Councilman Montgomery. Administrator Napier explained that the resolution is formal direction for staff to begin the analysis, mapping and reporting required statutorily. Mayor Carter-King began the discussion by inviting Dr. Michael Hughes to provide a history of the sewer issues and pre-annexation agreements. Dr. Hughes, previous Board Member, addressed the audience providing history of the Antelope Valley sewer issues. Lots in Antelope Valley were one acre lots and septic sewers were put in that worked well, for a while. Approximately 30 years ago, problems began with the septic sewers, and approximately 25 years ago sewer was coming up in some resident lots; when it rained some had to move out of their homes. Meetings began to take place between the Board and professional engineers, surveyors, City, County, and volunteers from Antelope Valley. The Board approached the City and asked for help with the sewer systems. After receiving two or three million dollars in grant funding, the City agreed that Antelope Valley could hook up to the City's sewer system. However, in order to hook up to the City's sewer system, a pre-annexation agreement needed to be signed. Mr. Hughes believes that over 90% of the homeowners signed the pre-annexation agreements. Mayor Carter-King then invited Dan King, current president of the South Douglas Hwy Water & Sewer District, to speak. Mr. King stated that he has served on the District Board for 14 years and provided history stating that the District worked to create the best, non-contiguous pre-annexation agreement with the City. The mill levy was reduced from 8 mills to 1 mill. At the time, 98% of Antelope Valley property owners voluntarily signed pre-annexation agreements to get the City sewer services that were needed. Mr. King is in favor of the annexation as he voluntarily signed the pre-annexation agreement in order to receive the necessary sewer services needed for his family. Mr. King requested that the City and the Antelope Valley Service District work together to dissolve the District and the City take over the water, streets and services, and then provided an approximate cost savings his property would see in a year if this happened. Mayor Carter-King then invited those who are opposed to the annexation to speak and laying down ground rules that included being respectful, addressing comments and questions to the Chair, providing the name and address of each speaker and each speaker will get two minutes to speak. Sheila Jeremiah, 1831 Wolf Rd; Chris Palmer, 1991 Wolf Rd; Dan Hood, 7561 Robin Dr.; Ted Conroy, 2530 Antler Rd; Clint Lee, 2651 Antler Rd; Karyl Meyer, 7601 Robin Dr.; Don McCreary, 1961 Wolf Rd; Brad Carey, 8280 Ptarmingan; Ann Weber, 7861 Chukar Dr., addressed Council regarding concerns and opposition to the annexation. Some concerns presented were: the lack of service the City could provide if Antelope Valley were annexed, no Council representation, the possibility of assisting property owners with the loan balance for the sewer that Antelope Valley residents are paying, the timing of Council's decision to annex Antelope Valley into the city, code compliance issues, the City taking over the water system, Mill Levies, what benefit is the City bringing to Antelope Valley, and paving driveways. The Council and staff ensured that until the Board requests water, the City will not take over the water system and Antelope Valley will not be mandated to do so, nor would curb and gutter required. Council replied to the comment regarding what the City was going to do for the residents of Antelope Valley, and asked where the residents would be if 15 years ago the City couldn't help with a sewer line. Attorney Davidson read a portion of the annexation agreement regarding paving of driveways. He reported that the land owner will not be required to pave existing off street parking or loading areas, however, the landowner agrees in the event the use of the property expands, the installation of an all-weather surface will be required in support of that expansion. Mr. Napier expanded on that by saying that the City will not mandate sidewalks, driveways, curb and gutter, and certainly not coming on to the City's water system. Those conditions are outlined in the preannexation agreement. The Mayor opened the discussion to those who are in favor of the annexation. Ann Weber, 7861 Chukar Dr., addressed the Council. She stated that she is in favor of the annexation and added that everyone knew what they were getting into. We needed the help. She requested, however, that if the City is not ready to take over in the entirety, which includes the water system, to postpone the annexation. Council reminded Ms. Weber, that decision is entirely up to the Board to request connection to City water. The Mayor closed the discussion by asking staff to provide a timeline of the annexation process. Director Hamilton explained petitions would be prepared and mailed to the property owners identified in the annexation, the mailing would go out approximately the first of April. Those petitions would be mailed to those who have pre-

annexation agreements, as well as those areas that don't have agreements that are contemplated being annexed into the City. Once petitions come back, approximately this fall, the annexation plat will be prepared and submitted into the planning process. Approximately September, the actual annexation packet would be submitted for review that will include reviewing the plat, statutory requirements of preparing an annexation report that will clearly identify the services that the City will provide, the tax impacts, etc. Ultimately, by the end of the calendar year, the annexation process will be finished. There will be a planning commission meeting, a public hearing with the city council as well as a resolution and first reading of the ordinance, which will require two additional readings of the ordinance. Mr. Napier concluded the discussion by suggesting another meeting with the residents of Antelope Valley and Crestview, or a one-on-one forum, to answer any additional questions or concerns the residents may have. Mr. Napier added that he appreciates some of the comments that have been made relating to some of the myths associated with an annexation. These are common and reasonable concerns of property owners. He touched on a comment made by one of the Antelope Valley residents, of the type of people that Wyoming people are. It's that same kind of ethic that the Antelope Valley residents appealed to 12-15 years ago from the citizens of Gillette. The citizens of Gillette responded favorably to the extent of opening their wallets and providing 3.2 million dollars when it was not their obligation to do. And it certainly meant deferring projects that would have benefited their neighborhood, their city and community directly. Not only did they open their wallets and provide 3.2 million dollars, under no obligation, they used their influence with the City Council of that day, to try and garner more money from the State of Wyoming, which they were successful in doing. The reality of it all is, not only did the citizens of Gillette agree to allow them to tap into the sewer, but they would garner their resources and open their own wallets, to make this connection happen so Antelope Valley did not have to be wallowing in their own waste to deal with a very serious health and safety issue. Mr. Napier's concern is, by rejecting the proposed Resolution, Council will be rejecting the notion that the City of Gillette did what they said they would do. Not only did the City do what they said they would do, they brought resources to the table to help follow up on what it is they said they would do. It also denies the City of Gillette one of the only means by way of which the citizens of Gillette can help themselves. The statute does not allow for cities and towns to have taxation authority and they do not allow for property tax contributions. The only thing cities and towns have the capacity to do is move into annexation agreements that promise some sort of financial benefit in the future. A rejection of this resolution denies Council's citizens the opportunity to get help when they need it. Mr. Napier's hope is that the Council recognizes the contribution of those who came before them, as well as recognizing the opportunity that exists right now and pass this Resolution. Mayor Carter-King asked Council to vote. All voted aye. The motion carried.

# AN ORDINANCE AMENDING SECTION 11-26 OF THE GILLETTE CITY CODE TO ADOPTED REVISED FINES FOR PARKING VIOLATIONS ON CITY OWNED PARKING LOTS

Councilman Carsrud made a motion to approve the foregoing Ordinance on first reading; seconded by Councilman McGrath. Administrator Napier explained that this ordinance would increase the fine for those who illegally park in a leased parking space during specified times. After the explanation, Councilman McGrath made a motion to amend the fee from \$75 to \$50; seconded by Councilman Barks. Councilmen Barks, Carsrud, McGrath and Montgomery voting aye. Councilmen Kuntz, Lundvall and Mayor Carter-King voting nay. The motion to amend carried. The Mayor called for a vote on the original motion as amended. Councilmen Barks, Carsrud, Lundvall, McGrath, Montgomery and Mayor Carter-King voted aye. Councilman Kuntz voted nay. The motion carried.

### **Appointments**

Councilman Barks made a motion to appoint Mayor Carter-King as the voting delegate and Administrator Napier as the alternate voting delegate to WAM's Convention Business Meeting on Friday, June 2, 2017, in Gillette, Wyoming; seconded by Councilman McGrath. Councilmen Barks, Carsrud, Kuntz, Lundvall, McGrath and Montgomery voted aye. Mayor Carter-King abstained. The motion carried.

### **Public Hearings and Considerations**

Mayor Carter-King opened a public hearing for the extension of the boundaries of the City of Gillette, Wyoming, and annexation of a tract of land known as the Country Club Lake Annexation, entirely adjacent and contiguous to the present boundaries of the City of Gillette, Wyoming, pursuant to W.S. 15-1-404, and establishing an A, agriculture zoning district and R-S, suburban residential zoning district, subject to all Planning requirements. Administrator Napier explained

that the request is to clean up the jurisdictional holes within the community. William Wright, owner of the property, inquired about the City Ordinances. Some of the property can be mowed and some of it is swamp land. Would this be an issue with code compliance? Mr. Napier stated that he is not aware of any concerns that the drainage areas Mr. Wright is referring to, are being done in a way that is inappropriate at this point in time. As it relates to residential areas, where there is a yard grown over with noxious weeds, there will be code issues that would require the property owner to maintain the property in a way consistent with the code. The drainages that the City owns will be maintained; privately owned drainages that have not been mowed in the past it is doubtful that there would be more requirements on the property owners, unless, again, there is an issue with noxious weeds. Mr. Wright informed the Council that he has an individual that plans to hay the property when he can. The public hearing was closed.
