Public Hearings and Considerations

Mayor Carter-King opened a public hearing to amend the district zoning map of the City of Gillette, Wyoming, for Lot 12, Block 4, Northside Addition, from R-2, Single and Two Family Residential District, to A, Agricultural District, subject to all Planning requirements. Administrator Napier advised Council that if they approve the requested zoning change, the petitioner would have to file a plat that would homogenize the property into one, with the removal of some of the property lines, which would allow for further agricultural development in the area. Administrator Napier informed Council that the Planning Commission approved the zoning change with the caveat that the size requirements could be waived, to a certain degree, with the approval of the City Council and the filing of a plat. Mayor Carter-King asked if staff had any concerns about the zoning amendment. Mr. Napier stated that as the zoning code is currently written, the size requirements would not allow for this zoning amendment. However, if the petitioner would agree to the plat requirements recommended by the Planning Commission, staff would have no problem with the zoning amendment. David Bundy, property owner, stated that he plans to build a pole barn on the property for personal storage purposes. Mayor Carter-King asked Mr. Bundy if he would be willing to file the plat as recommended by the Planning Commission. Mr. Bundy stated that the documents have been prepared and would be filed with the County upon approval from the City. The public hearing was closed.
