Ordinance 1st Reading

ORDINANCE 17-26

AN ORDINANCE CONCERNING THE CREATION OF THE CITY OF GILLETTE, WYOMING, SPECIAL IMPROVEMENT DISTRICT NO. 52; ORDERING THE CONSTRUCTION AND INSTALLATION OF A NEW WATER SYSTEM AND ALL NECESSARY APPURTENANCES FOR THE SUBDIVISION COMMONLY REFERRED TO AS INTERSTATE INDUSTRIAL PARK, ALONG WITH THE NECESSARY SURFACE RECLAMATION OF GRADING AND VEGETATION; DESCRIBING THE SAME; DIRECTING THE CITY ENGINEER TO PREPARE THE PLANS AND SPECIFICATIONS THEREFOR; FIXING THE BOUNDARIES OF SAID DISTRICT; RATIFYING ALL CONSISTENT ACTION PREVIOUSLY TAKEN CONCERNING SUCH; AND PRESCRIBING DETAILS IN CONNECTION WITH SAID DISTRICT.

Councilman McGrath made a motion to approve the foregoing Ordinance on first reading; seconded by Councilman Barks. Interim Administrator Wilde and Director VonEye provided an explanation regarding the consideration. Councilman Barks stated that from a previous public hearing, there was confusion as to what the costs will be associated with this project, and asked if the costs had been determine more accurately. Director VonEye stated that the costs are still the same as they were in the previous discussion. The notice that went out to the property owners contained a "worst case scenario" which equated to a \$56,000 assessment per property owner. Other facts that weigh into this is a \$500,000 principal forgiveness on a \$2,000,000 loan, which would bring the property owners' assessment down to the mid \$40,000 range. The other reality is that some of the property owners will pay the assessment up front and will not accrue interest on their assessment, and that equates to a \$35,000 - \$36,000 assessment. After the discussion, all voted aye. The motion carried.

Appointments

Councilman Barks made a motion to appoint Terry Sjolin to the Gillette Historic Preservation Commission's one partial term, expiring on June 30, 2018; seconded by Councilman Lundvall. All voted aye. The motion carried.
