

**ONE PERCENT TAX EDUCATION AGREEMENT BETWEEN  
CAMPBELL COUNTY, THE CITY OF GILLETTE, THE TOWN OF  
WRIGHT, AND THE CAMPBELL COUNTY CHAMBER OF  
COMMERCE.**

**THIS AGREEMENT** is made and entered into at Gillette, Wyoming by and between Campbell County, hereinafter called "COUNTY", located at 500 South Gillette Avenue, Suite 1100, Gillette, Wyoming 82716; and the City of Gillette, a Municipal Corporation of the First Class of the State of Wyoming, P.O. Box 3003, Gillette, Wyoming 82717, hereinafter called "CITY"; and the Town of Wright, P.O. Box 70, Wright, Wyoming 82732, hereinafter called "TOWN"; and the Campbell County Chamber of Commerce, a Wyoming corporation, 314 South Gillette Avenue, Gillette Wyoming, 82716 hereinafter called "CHAMBER". The COUNTY, CITY, TOWN and CHAMBER may be collectively referred to as "PARTIES".

**WHEREAS**, the voters of Campbell County will vote on the continuation of the local 1% tax at the general election this November 6, 2018.

**WHEREAS**, the PARTIES wish to provide the voters with educational information concerning the projects funded by the tax in the past and to seek their input concerning projects to be funded in the future.

**NOW THEREFORE**, the PARTIES agree as follows:

1. The CHAMBER shall prepare and administer a survey to the residents of Campbell County to determine their funding priorities for 1% tax revenues received over the next four years, assuming the tax is approved by the voters on November 6, 2018. A copy of the tentative survey is attached and marked Exhibit A and final content of the same shall be approved by the PARTIES. In addition, the CHAMBER shall prepare and distribute a report, with input from the CITY, the TOWN and the COUNTY, which shall list and discuss the various projects funded in whole or in part by the 1% tax revenues received since the previous election. The PARTIES agree that the final survey shall be distributed by mail as soon as possible but in any event no later than September 21, 2018 and that the survey will be conducted in a statistically valid and reliable manner. The CHAMBER shall

finalize the survey instrument, report and survey methodology and shall furnish copies to the CITY, the TOWN and the COUNTY for comment prior to mailing.

2. The CITY, the TOWN and the COUNTY shall pay the CHAMBER \$19,485.00 for its services under this agreement, apportioned according to the percentage of sales tax received by each entity during the last four years, or 63.05%, 3.92% and 33.03%, respectively. The CITY shall pay \$12,285.29, the TOWN shall pay \$763.81 and the COUNTY shall pay \$6,435.90 to the CHAMBER within thirty (30) days of the execution of this agreement.

3. In order for the CITY, the TOWN and the COUNTY to evaluate the quality of the performance rendered by the CHAMBER under this agreement, the CHAMBER shall submit a report detailing its efforts to survey and educate the public concerning the 1% tax.

4. The PARTIES agree that the CHAMBER is an independent corporation and is acting at all times as an independent contractor of the CITY, the TOWN and the COUNTY and not as their agent, nor shall any employee of the CHAMBER be considered an employee of the CITY, the TOWN or the COUNTY by virtue of their work on this project. The PARTIES acknowledge and agree that this agreement is solely to educate and survey and that no actions are contemplated nor authorized which would violate any law of the State of Wyoming, including specifically any law relating to the conduct of elections or the support of ballot propositions.

5. This agreement shall begin on the date it is executed by the PARTIES and shall be in full force and effect until December 31, 2018. The terms of this agreement shall bind the parties hereto and their successors and assigns. This agreement shall not be assigned in whole or in part without the prior written approval of the PARTIES. Any assignment without the prior written approval of the PARTIES is void.
