Councilman Carsrud made a motion to approve a conflict claim for Mayor Carter-King in the amount of \$32.49; seconded by Councilman Lundvall. Brown, Carsrud, Lundvall, McLeland, and Neary voted aye. Mayor Carter-King abstained. The motion carried.

#### **Comments**

<u>Council Comments</u> – Councilman McLeland thanked all who organized and participated in the Memory of the Eight Run. The event was well done and very successful.

<u>Public Comments</u> – Toni Brown of the Civil Air Patrol asked Council to consider a Proclamation for the designation of December 14, 2019 as "Wreaths Across America Day". (The formal proclamation is scheduled for the November 5, 2019, Council meeting.) Ms. Brown introduced two (2) cadets who explained the wreath sponsorship program. Ms. Brown was hopeful that Council would participate in the 2019 sponsorship program.

Gillette Little League Board Member, Rory Geis, informed Council of the variety of ways the Gillette Little League has benefited community youth over the past 50 years. He expressed dismay that the lease with the City would not have an option for renewal, and concern regarding the scheduling and operation of the Little League program. Various citizens and board members expressed frustrations with the non-renewal of the annual Little League Lease. City Administrator Davidson explained the potential benefits of the proposed process changes. Mayor Carter-King asked for the cooperation of Little League, and assured them the process changes would work well for all who utilize the fields.

Other Comments – The Mayor and Council recognized the City's Finance Staff for achieving a Certificate of Achievement for Excellence in Financial Reporting from the Government Finance Officers' Association for the seventh consecutive year.

#### **New Business**

#### **Minute Action**

Councilman Carsrud made a motion to approve a concession stand lease at the Energy Capital Sports Complex between Gillette Girls Fastpitch Association, Inc., and the City of Gillette, Wyoming, through September 30, 2020; seconded by Councilman Neary. Administrator Davidson provided an explanation regarding the consideration. All voted aye. The motion carried.

Councilman McLeland made a motion to approve a concession stand lease at Dalbey Memorial Park Little League Baseball Fields, between Gillette Little League and the City of Gillette, Wyoming, through September 30, 2020; seconded by Councilman Brown. Administrator Davidson explained the provisions of the lease, and stated that Gillette Little League did not submit a signed lease for consideration. Mayor Carter-King asked for direction on how to proceed with the consideration. Administrator Davidson stated that Staff's recommendation would be to disapprove the lease, and allow staff to solicit requests for proposals for the ECSC concessions. Little League Board Member, Melissa Blankenship, explained that the board would elect new officers at their September 25th meeting, and felt that the new board should make the decision to sign the lease. Mayor Carter-King stated that Gillette Little League would be able to submit a proposal for the concessions. Councilman Carsrud asked if there, currently, was a lease available for the board to sign. Mike Leisy, President of the Gillette Little League, explained that his term of office would expire in a few weeks, and he didn't want to commit the next board to a lease. He requested that Council post-pone the consideration of the lease until the end of meeting to give the board time to discuss and decide. Out of respect for the new board, Mr. Leisy preferred to have the newly elected President make the decision to sign the lease. City Attorney advised Council to disapprove the lease, citing that the deadline for returning the signed lease had already been extended, with noncompliance by Gillette Little League. Councilman Carsrud stated that he would accept the lease if it were signed at the meeting; Councilmen Neary and Brown agreed. Mr. Leisy reiterated that he felt it should be the duty of the newly elected board president to make the decision to sign the lease, and with his term coming to an end, he was not comfortable signing a lease that would obligate the new board. City Attorney Reyes pointed out that it was never a good decision to have an agreement signed under duress. Councilman Carsrud made a motion to table item H.1.b. to the end of the action items, as H.3.a.; seconded by Councilman Lundvall. All voted aye. The motion carried.

Councilman Carsrud made a motion to accept public improvements for the 2019 New Sidewalks Project, installed by Black Cat Construction, in the amount of \$58,317 (1% Project); seconded by Councilman Brown. Administrator Davidson provided an explanation regarding the consideration. All voted aye. The motion carried.

Councilman Lundvall made a motion to approve a professional services agreement for Design and Bidding Services associated with the 2020 Pavement Management System (PMS) Project, with Kadrmas, Lee, & Jackson, in the amount of \$219,276 (1% Project); seconded by Councilman Brown. Administrator Davidson provided an explanation regarding the consideration. All voted aye. The motion carried.

Councilman Carsrud made a motion to approve a professional services agreement for Design and Bidding Services associated with the Crestview Sanitary Sewer Improvements, with DOWL, in the amount of \$61,036 (1% Project); seconded by Councilman McLeland. Administrator Davidson provided an explanation regarding the consideration. All voted aye. The motion carried.

Councilman Carsrud made a motion to accept public improvements for the Wastewater Treatment Facility Anaerobic Digester Cleaning and Coating Project to R.C.S. Construction, Inc., of Rapid City, South Dakota, in the amount of \$470,737.87; seconded by Councilman McLeland. Administrator Davidson provided an explanation regarding the consideration. All voted aye. The motion carried.

Councilman Brown made a motion to approve a professional services agreement for the Gillette Regional Water Supply Project – Phase III District Extensions to HDR for Engineering Design Services in the amount of \$580,901; seconded by Councilman McLeland. Administrator Davidson provided an explanation regarding the consideration All voted aye. The motion carried.

Councilman Neary made a motion approve the foregoing Resolution for the City's Health Plan Premiums and Plan Design changes effective January 1, 2020; seconded by Councilman Carsrud. Administrator Davidson provided an explanation regarding the consideration. All voted aye. The motion carried.

# ORDINANCE NO. 19-17 AN ORDINANCE TO AMEND CHAPTER 11, SECTION 11-10 OF THE GILLETTE CITY CODE TO REVISE CITY SNOW ROUTES AND SNOW EMERGENCY DECLARATIONS

Councilman Carsrud made a motion to approve the foregoing Ordinance on first reading; seconded by Councilman Lundvall. Administrator Davidson and Mayor Carter-King provided explanations regarding the consideration. The Ordinance would limit parking from November 1st through March 31st of each year, on Foothills Boulevard from Goldenrod to Highway 14-16, 4th Street from 4-J Road to Gillette Avenue, 6th Street from Burma Road to Gillette Avenue, and 7th Street from 4-J Road to Gillette Avenue. The parking restriction would help to create a safer environment for snow plowing, allow for better road maintenance, and decrease the number of accidents, particularly on streets highly utilized by emergency response vehicles. Elaine Jessen and John Yarkosky expressed concern that not allowing parking on 4th Street in front of their establishments would have an adverse effect on their business. Director Wilde explained that the areas of limited parking encompass extreme hills and surfaces that impede snow removal, which create hazards. Mayor Carter-King requested the addition of this topic to the September 24th Work Session agenda for further discussion. All voted aye. The motion carried for the Ordinance on first reading.

# ORDINANCE 19-18 AN ORDINANCE TO AMEND CHAPTER 14, SECTION 14 A OF THE GILLETTE CITY CODE TO REVISE CITY PARK HOURS

Councilman McLeland made a motion to approve the foregoing Ordinance on first reading; seconded by Councilman Brown. Administrator Davidson provided an explanation regarding the consideration. All voted aye. The motion carried for the Ordinance on first reading.

Councilman Brown made a motion to remove Item H.1.b. from the table to approve a concession stand lease at Dalbey Memorial Park Little League Baseball Fields, between Gillette Little League and the City of Gillette, Wyoming, through September 30, 2020; seconded by Councilman Lundvall. All voted aye. The motion to remove the item from the table carried. Mike Leisy, President of the Gillette Little League, agreed to sign the concession stand lease. City Attorney Reyes announced that the lease had been signed, and Council could proceed with the consideration of the lease. All voted aye. The motion carried.

## **Adjournment**

Mayor Carter-King recognized the Gillette Little League for all they have done for the baseball organization, and expressed hope that the good working relationship between the Gillette Little League Board and the City can continue for many years. There being no further business to come before the Council, the meeting adjourned at 8:31 p.m. The next regularly scheduled meeting will be held on October 1, 2019, Council Chambers, City Hall.
