Dear Mr. Jensen,

We have reviewed the bid forms and bid bonds submitted for the above referenced project. The original bids and bid tabulation sheet are attached for your use.

The four bidders on the project were Hot Iron, Inc., DRM, Inc., Mountain View Building, Inc., and Western Municipal Construction of Wyoming, Inc. All bids were submitted on time, had the required Bid Bonds and acknowledged Addendum No. 1. The bids from Hot Iron, DRM and Mountain View Building also included a Residency Certificate. Western Municipal Construction of Wyoming did not include a Residency Certificate and an additional 5% of cost was added to their final bid for comparison. No irregularities were found that would justify rejection of a bid.

The bids for the project ranked as follows:
