AMENDMENT NUMBER THREE TO TELECOMMUNICATIONS RIGHT OF WAY USE AGREEMENT BETWEEN VISIONARY COMMUNICATIONS, INC., AND THE CITY OF GILLETTE, CAMPBELL COUNTY, WYOMING

1. <u>Parties</u>. This Amendment is made and entered into by and between Visionary Communications, Inc. ("Company"), whose address is 1001 S. Douglas, Suite 201, Gillette, WY, 82716; the City of Gillette, Campbell County, Wyoming, ("City") whose address is 201 East 5th Street, Gillette, WY 82716.

2. <u>Purpose of Amendment</u>. This Amendment shall constitute the third amendment to the Agreement between the Company and the City which was duly executed on September 18, 2017, and which became effective September 18, 2017 ("Original Agreement"). The purpose of this Amendment is to allow the Company additional use of the public right-of-way for the installation of conduit to maintain a fiber optic communications system, as more fully described in Facility Location Map(s), VCN-B-017 through VCN-B-021, which is attached as Exhibit D and made a part of this Agreement. In addition, the Original Agreement is modified to clarify the Company's obligation to obtain easements and other permissions over private property.

The Original Agreement, dated September 18, 2017, provided for the limited use of the public right-of-way for the installation of conduit to maintain a fiber optic communications system for the initial installation fee of one dollar and fifty-two cents (\$1.52) per foot; and twelve cents (\$.12) per foot fee annually for each foot of City right of way encumbered by the Company beginning on the first day of January following the initial installation.

Amendment Number One, dated November 7, 2018, allowed the Company to add additional use of the public right-of-way and provide additional Facility Location Map(s), VCN-B-003 through VCN-B-015.

Amendment Number Two, dated February 5, 2019, allowed the Company to add additional use of the public right-of-way and provide additional Facility Location Map(s), VCN-B-016.

- 3. <u>Term of the Amendment</u>. This Amendment shall commence upon the date the last required signature is affixed hereto, and shall remain in full force and effect through the term of the Original Agreement.
- 4. <u>**Payment.</u>** The Company agrees to pay the City an installation fee of one dollar and fifty-two cents (\$1.52) per foot as more fully described in Exhibit D. The Company agrees to pay an additional installation fee of one dollar and fifty-two cents (\$1.52) per foot for every subsequent conduit or raceway associated with any additional Facility Location Map. The Company agrees to pay an annual twelve cents (\$1.2) per foot fee for each foot of City right of way encumbered by the Company beginning on the first day of January following the initial installation.</u>

5. Additional Responsibilities of Contractor.

A. The parties agree to the modification of Section 5. L. of the Original Agreement to read as follows:

The Company shall submit new construction designs to City L. Electrical Engineering for approval. Designs shall meet current City Fiber Construction Standards (Section 16010), unless an alternate design is approved in writing by City Electrical Engineering. The Company may not direct bury fiber optic cables, unless prior written approval is received from the City Electrical Engineering Division (City West Building, 611 N. Exchange Ave., Gillette, WY 82717, Phone (307) 686-5277, Fax (307) 686-6564). Prior to installation of raceways that require access to private property, the Company shall obtain a Permanent Access and Utility Easement from the property owner. The Easement shall be recorded with the Campbell County Clerk. A copy of the recorded easement shall be provided to the City Electrical Engineering Division. Once the Company has installed raceways, then the Company may pull/install unlimited fiber pairs within one or more of the raceways.

- 6. <u>Additional Responsibilities of Agency</u>. The City has not taken on any additional duties.
- 7. <u>Special Provisions</u>
 - A. Same Terms and Conditions. With the exception of items explicitly delineated in this Amendment, all terms and conditions of the Agreement between the City and the Company, including but not limited to governmental immunity, and including all prior amendments to this Agreement shall remain unchanged and in full force and effect.

8. General Provisions

A. Entirety of Contract. This Amendment, consisting of three (3) pages, and Exhibit D, VCN-B-017 through VCN-B-021 – Facility Location Map(s), and the Original Agreement consisting of ten (10) pages, and Exhibit A - Facility Location Map(s); Amendment Number One consisting of three (3) pages, and Exhibit B, VCN-B-003 through VCN-B-015 – Facility Location Map(s) and Exhibit C, VCN-B-016 – Facility Location Map(s) represent the entire and integrated Agreement between the parties and supersedes all prior negotiations, representations, and agreements, whether written or oral.






