Understanding of the Project

We have reviewed the Bid Documents for the Construction portion of this Project and feel comfortable with our knowledge of the scope of the work. The general work to be provided is similar to projects that we have been involved with in the past where landscaping and irrigation improvements have been made. Consolidated Engineers, Inc. has also worked with several landscape architects on the designs and limited construction observation of playgrounds at the last five (5) new elementary schools constructed in Gillette as well as those in Sundance and Lingle.

The construction phase services that are described in the Request for Proposals is nearly identical to the part-time construction observation we have supplied to the City of Gillette on numerous projects in the past, including the 8th and Stocktrail Drainage (23EN07) which is currently under construction.

Knowledge of Playground Safety Requirements

We have reviewed the general standards and practices as related to playground safety published by the National Recreation and Park Association. Based on that review, we see nothing that is a concern to us or beyond our abilities. If questions arise during construction, we will consult their requirements and be in communications with Russell + Mills Studios to get their input and guidance.

Knowledge of Land and Water Conservation Fund Requirements

We have reviewed the general federal funding requirements and practices as related to Land and Water Conservation Fund Projects. Based on that review, we see nothing that is a concern to us or beyond our abilities.

Schedule and Availability of the Project Team

Per the Bid Documents for the Construction portion of this Project, the Contractor has a maximum of sixty (60) working days November 22, 2024.

Our firm currently has the room in our schedule to complete this Project within the above listed time frames. As far as our current contracted workload, the only projects we have going on that could require one person for close to or more than half a day for extended periods of time are the following:

- Construction observation of the YES House Pavement Repairs project which will require a single staff member. These improvements are scheduled to be complete by the middle of August at the latest.
- Construction observation of the City of Gillette's 2024 Crack Sealing (24EN14) project which will require a single staff member. These improvements are scheduled to be started no earlier than August 19th and completed by October 31, 2024 at the latest.



Description: The purpose of this project is to address storm water drainage concerns at the intersection of 8th Street and Stocktrail



Avenue. Water currently leaves the gutters on 8th Street and flows across the intersection and also causes issues downstream at the Campbell County Senior Center. This project is currently in the construction phase.

Description: The purpose of this project was to address general drainage concerns and basement water infiltration around the administrative portion (south end) of Fire Station 1. The design included the replacement of the failing downspout collection system and regrading to ensure adequate drainage away from the building.



As a result of the extensive grading and excavation, the majority of the existing landscaping was removed. Decorative concrete aprons were installed adjacent to the building to

prevent water infiltration, replacing the landscape bushes that had been present. Extensive sprinkler system modifications were required and new trees and bushes were installed.

Scope of Services: Our agreement for this project included design phase, bidding phase assistance, and construction phase services. The construction observation services included a part-time RPR, daily reporting, tracking of quantities for payment request review, and providing general services civil engineering oversight for the work. Also included was coordination between the contractor, the landscape/irrigation subcontractor, and the Campbell County Parks representative.





Land Surveying Incorporated

In the event that as-constructed locations of the eight (8) pieces of playground equipment that have "safe-zones" and survey the limits of the soft safe-zone areas are requested, this service will be provided by Land Surveying Incorporated through a subcontract with Consolidated Engineers, Inc. Part of these optional services would be to create a certified exhibit showing the dimensions from the required safe-zones to the as-constructed limits of the installed soft safe-zone material. We have worked with Land Surveying Incorporated since the start of their company in 2000.

Consolidated Engineers, Inc. proposes to provide civil engineering services for the Construction Management and Construction Administration of this Project with in-house personnel with assistance from Land Surveying Incorporated,. The following sections describe the scope of the engineering services. Where these vary from those listed in the EJCDC E-500 document provided with the Request for Proposal, that document will need to be modified to these.

I. TASK 1 - CONSTRUCTION PHASE SERVICES

- A. Organize and attend a pre-construction meeting with Owner and the construction Contractor to determine schedules and to establish chains of communications. The meeting will have notes taken to document items that were discussed that will be typed up and distributed to all in attendance.
- B. Obtain from Russell + Mills Studios digital copies of the final design in a format compatible with the Contractor's surveyor and provide such to the Contractor.
- C. Provide part-time Resident Project Representative (RPR) services with such duties and responsibilities as set forth in the EJCDC E-500 document provided with the Request for Proposal. It is assumed that daily one and one-half (1.5) hour construction observation tours per day for a period of no more than sixty (60) days will be sufficient for the majority of the Project. It is also assumed that a second one and one-half (1.5) hour construction observation tours per day will be required on eight (8) days when critical construction items are scheduled.
 - (Additional visits as requested by Client will be on a time and materials basis.)
- D. Provide Daily Construction Reports for each site observation tour that are to be submitted weekly on Monday following the previous week's work. These will include photographs incorporated into them as needed to document construction progress and as needed to define "problem areas".
- E. Receive and review material testing reports as received from the Contractor.
- F. Arrange for and attend up to eight (8) biweekly construction progress meetings with Owner and the Contractor to determine compliance with schedules and to discuss construction related concerns. The meetings will have notes taken to document items that were discussed that will be typed up and distributed to all in attendance. (These meetings are assumed to be on-site.)
- G. Provide Project Engineer's services as described in EJCDC E-500 document provided with the Request for Proposal, generally as follows:
 - 1. Review up to five (5) applications for payment submitted by the Contractor. This includes in-field measurements of installed and/or removed pay item quantities.
 - 2. Prepare and recommend RFI's, Change Orders, and similar documents with input from Russell + Mills Studios.
 - 3. Receive and transmit shop drawings, schedules, submittals and proposed alternatives received from the Contractor and transmit to Russell + Mills Studios for their review and approval.
 - 4. Answer questions form the Contractor concerning the construction.
- H. Arrange for and conduct a Final Completion review of the work to check conformance of the work with the contract documents. A representative of Russell + Mills Studios will be invited to this review. Prepare notes of that review and prepare the Notice of Final Completion.
- I. Receive the as-constructed survey data gathered by the Contractor's surveyor and transmit the data to Russell + Mills Studios for their use in creating on the "Drawings of Construction Record".

II. TASK 1A - OPTIONAL STAKING REVIEW SERVICES

Contract with Land Surveying Incorporated to provide the following construction staking review services:

- 1. Survey the as-constructed locations of the eight (8) pieces of playground equipment that have "safe-zones" and survey the limits of the soft safe-zone areas.
- 2. Create a certified exhibit showing the dimensions from the required safe-zones to the as-constructed limits of the installed soft safe-zone material.

III. TASK 1B - REVIEW OF LWCF SUBMITTALS SERVICES

Provide review and verification of the accuracy of documentation requested or required by LWCF, given that such documentation will depend in whole or in part upon information provided by the city of Gillette. These services will be provided on a time and materials basis.

IV. TASK 1C - OPTIONAL REDUCTION IN ON-SITE OBSERVATION TOUR SERVICES

As a possible option to reduce overall Project costs, the number of on-site observation tours for a typical five (5) day work week could be reduced down to only three (3) tours per week. Based on the type of construction that this Project includes, daily on-site observation tours are probably not required to ensure that the construction requirements are achieved.

A. Background:

Infrastructure includes facilities that generate, transport, and distribute energy. Infrastructure includes all amenities funded through this Agreement.

5. "Project" means the construction, alteration, maintenance, or repair of infrastructure in the United States.

C. Infrastructure Requirements:

Recipients of an award of Federal financial assistance are hereby notified that none of the funds provided under this award may be used for a project for infrastructure unless:

- 1. all iron and steel used in the project are produced in the United States--this means all manufacturing processes, from the initial melting stage through the application of coatings, occurred in the United States;
- 2. all manufactured products used in the project are produced in the United States —this means the manufactured product was manufactured in the United States; and the cost of the components of the manufactured product that are mined, produced, or manufactured in the United States is greater than 55 percent (55%) of the total cost of all components of the manufactured product, unless another standard for determining the minimum amount of domestic content of the manufactured product has been established under applicable law or regulation; and
- 3. all construction materials are manufactured in the United States—this means that all manufacturing processes for the construction material occurred in the United States.

The Buy America preference only applies to articles, materials, and supplies that are consumed in, incorporated into, or affixed to an infrastructure project. As such, it does not apply to tools, equipment, and supplies, such as temporary scaffolding, brought to the construction site and removed at or before the completion of the infrastructure project. - l. A statement of waiver justification, including a description of efforts made (e.g., market research, industry outreach) by the recipient, in an attempt to avoid the need for a waiver. Such a justification may cite, if applicable, the absence of any Buy America-compliant bids received in response to a solicitation.
